QUALIFYING CHARACTERISTICS

GENERAL PRESENTATION OF THE DOCTORAL PROGRAM

The doctoral program in Choreography is intended for the Educational Qualification Degree Master's graduates who are interested in research in the field of dance art.

The Faculty of Arts, Department of Choreography, in accordance with the modern scientific achievements provides the training of the doctoral students.

The Faculty of Arts at South-West University 'Neofit Rilski' provides training for doctoral students within the framework of the existing traditions, experience and a base for research, education and artistic activity. The training of doctoral students is aimed at research in the field of different areas of dance art – respectively, Bulgarian folk dances, classical dance, modern dance, sports dances, typical dances, and author's choreography.

OBJECTIVES OF THE DOCTORAL PROGRAM

The goal of the doctoral program in *Choreography* is to train highly qualified specialists and experts in the field of choreography by expanding one's fundamental theoretical and professional training and developing a dissertation on a problem topical for science and for the public practice.

GENERAL QUALIFICATION AND SPECIALIZATION OF THE PROGRAM

The doctoral student in Choreography prepares for independent research in the field of choreography. The main emphases laid down in the curriculum of the doctoral program in

Choreography are related to the upgrading of the knowledge already obtained in the field, as well as the acquisition of the necessary educational, scientific and creative experience of the trained doctoral students.

Full-time and unsupervised training is three years, and part-time -4 years.

The educational process is planned according to an individual curriculum, including educational, research and pedagogical activities.

The *individual curriculum* of the doctoral student is worked out by the doctoral student and his/her supervisor, then is accepted by the departmental council and approved by the faculty council. It outlines the direction of the doctoral studies and gives details about the activities to be carried out year by year.

The planned activities in the individual curriculum are distributed by semesters and classroom and independent activities are planned for them. Five compulsory and optional subjects should be studied.

KNOWLEDGE, SKILLS AND COMPETENCES ACQUIRED ACCORDING TO THE NATIONAL QUALIFICATIONS FRAMEWORK

1. Knowledge (theoretical and/or factual)

During the training process, the doctoral student acquires the following knowledge: accomplishing critical analyzes in the field of dance art and synthesizing new creative and choreographic ideas; mastering the methodology of scientific research in the field of dance art; training the ability to expand and modify the existing knowledge in the field of choreography in relation to Bulgarian folk dances, classical dance, modern dance, sports dances, typical dances, author's choreography, as well as in the interaction of dance art with adjacent scientific areas such as musical art, scenography, costume design, ethnography, etc.

2. Skills (cognitive and/or practical)

During the training process the doctoral student acquires the following skills: to create and manage scientific and creative centers related to choreography, etc.; to form creative teams for accomplishing stage choreographic products; to solve complex problems in the field of dance art through new methods and approaches; to find, obtain, arrange, synthesize and evaluate information from various sources; to solve and overcome critical problems in the field of research and/or innovation; to analyze and classify choreographic works; to be skilled in methods and means to anticipate changes and problems in the field of choreography; to abstract from the environment and to think creatively and innovatively; to develop and put forward innovative ideas for development.

3. Independence and responsibility

The PhD student creates and interprets new knowledge in the field of choreography, art history, ethnochoreology and other related scientific fields through own research or other scientific activity; has the ability to judge through the new knowledge gained; creates up-to-date publications; has the ability to self-assess the achievements of the accomplished research work; has the ability to design, project, implement and adapt a modern research process with scientific soundness.

4. Competence to learn

Demonstrates a capacity to systematically acquire and understand a significant amount of knowledge from the latest scientific achievements or from the field of art and choreographic professional practice.

5. Communicative and social competences

Has rich professional culture and communication skills; demonstrates independence and initiative, oriented towards ensuring personal information awareness and facilitating professional contacts with Bulgarian and foreign scientists; social activity, adaptability and competitiveness on the labor market, ensuring one's realization in specific social conditions; ability to work in a team.

6. Professional competences

Methodological competences in the field of scientific research; competencies in the field of methodology, methods and instrumentation of scientific and specialized research; professional skills to enrich choreographic theory; professional competences for independent teaching and expert activity in the field of choreography; ability to continue research in the field of choreography at increasingly sophisticated levels, contributing to the development of new ideas or approaches.

AREAS OF PROFESSIONAL REALIZATION

Independent research in the field of choreography; scientific and teaching work in higher schools in academic disciplines corresponding to the scientific specialty Choreography and related to it; management activity in the educational system in positions that require the corresponding level of scientific qualification; expert activity in positions involving the solving of research and practical tasks in scientific research institutes, higher schools, media.
