QUALIFICATION CHARACTERISTIC

1. GENERAL INTRODUCTION OF THE DOCTORAL PROGRAM

Specialty "Philosophy" offers a study program for doctoral students in the educational and scientific degree "Doctor"/Ph.D., in the scientific specialty "History of philosophy". The program is designed for masters who have completed philosophy, but also a wide range of humanities specialties. In certain areas and projections it is also suitable for students educated in the professional field of natural sciences.

The program aims to develop innovative theoretical thinking, backed by a rich historical-philosophical culture.

Modern research approaches, methods and forms are used philosophizing. Through the educational process, the expansion of the fundamental is ensured theoretical and professional study by developing a dissertation on fundamental or applied problem for science and public practice in accordance with the high modern requirements and the need to immediately bind the scientific theory with the spiritual challenges of the age.

The aim of the philosophy college at SWU "Neofit Rilski" is to establish the doctoral program as a main form of organized training of highly-qualified personnel in the field of philosophy. In the spirit of the requirements of the Bologna Process, the teachers from the Faculty of Philosophy consistently works for a thorough assimilation by the doctoral students of systematized knowledge in the field of the history of philosophy and for mastering the basic skills and methods for independent scientific research. It is part of our entry into the spirit of Europe. The emphasis in the training of doctoral students is also placed on building capacities for critical philosophizing, evaluation and synthesis of the new globalist and postmodern ideas, interpretations and approaches in philosophical studies. Attention is paid to the formation of doctoral students as young scientists possessing the ability to freely communicate with colleagues from the professional community as well as with a wider audience. The last one is special importance considering the specifics of the region and, more generally, the level of development of Bulgaria as a member of the European Union.

The program is guided by the motto: the lack of the first 7 years in upbringing is trouble; the absence of the first 2700 years in education is a tragedy.

2. DOCTORAL PROGRAM GOALS AND OBJECTIVES

The purpose of the doctoral studies in the scientific specialty "History of Philosophy" is to train highly-qualified personnel with sufficient scientific potential, who with knowledge and research skills to contribute to the development of spirituality in Bulgaria.

Doctoral students prepare to work with classical texts. Their practice is the theoretical study and research. The formation of innovative thinking is the main priority of the program.

Doctorate holders can be realized in many fields of the modern life at home and abroad: science, education, cultural sphere, management activities, project activity and many etc.

3. GENERAL QUALIFICATION AND SPECIALIZATION OF THE PROGRAM

Theoretically, the doctoral program in "History of Philosophy" also covers traces the historical-philosophical development from Antiquity to the end of the 19th century. In doctoral

students studying in the doctoral program have a specialized plan possibility of specific topologizing of a philosophical problem in the different historical and philosophical periods, as well as the problematization of a specific concept in its genesis and development during these periods.

4. KNOWLEDGE, SKILLS AND COMPETENCIES ACQUIRED ACCORDING TO THE NATIONAL QUALIFICATIONS FRAMEWORK

4.1 Knowledge (theoretical and/or factual)

Doctoral students who have completed the doctoral program in "History of Philosophy" must possess systematized knowledge in the field of historical-philosophical development and applying critical analysis. To have mastered methods related to the realization of scientific study in philosophy. Acquisition of knowledge at the highest level in the field of philosophy, as well as in related humanitarian fields, to possess the ability to expansion and problematic modification of existing knowledge in the field of philosophy and in other related scientific fields.

4.2. Skills (cognitive and/or practical)

Ability to implement interdisciplinary research methodology in the field of humanitarian studies. The doctoral students who completed the doctoral program in "History of Philosophy" must be able to carry out critical research and to freely handle the philosophical transcendental-logical, hermeneutic and phenomenological methodology. To have skills to expand and overcome raise research problems as well as develop innovative ones theoretical solutions.

4.3. Individuality and responsibility

Doctoral students in the program must create and integrate new knowledge through independence of the research, as well as to expand the scope of the philosophical theorizing through adaptation in current issues; to own an independent assessment of the achieved results of the studied philosophical issues; and to have the ability to adapt in the modern research process.

4.4. Competence to learn

Doctoral students in the program must demonstrate a capacity for systematic philosophical acquisition of knowledge and its meaning and understanding; to show competences in understanding scientific research, publication activity and orientation in modern bibliographic and scientometric systems.

4.5. Communicative and social competence

Doctoral students must demonstrate competences for conceptualization and implementation of projects for new knowledge, as well as application and understanding of the most modern theoretical achievements in the field of philosophical knowledge. To own language competence to allow the free exchange of theoretical material and dissemination of ideas.

4.6. Professional competence

Doctoral students in the "History of Philosophy" program must understand in details the techniques for applying scientific and academic research. To have a competent one judgment on complex questions in the field of philosophy, even in the absence of complete data; to present his ideas systematically and to derive and problematize philosophically concepts to specialists and non-specialists in the field. To have the ability to continues his research in the relevant philosophical field of more complex conceptual levels by contributing to the development of new ideas and theoretical methods.

The educational and scientific degree "Doctor"/Ph.D. is acquired after fulfilling the obligations under Art. 46, paragraph 2 of the Higher Education Act, Art. 9, paragraph 2 of Law for the Development of Academic Staff in the Republic of Bulgaria, section II, the Regulations for the

Implementation of the Law for the Development of Academic Staff in the Republic of Bulgaria, and according to the Conditions and procedure for acquiring the educational and scientific degree "Doctor"/Ph.D. from the Internal Rules for the Development of the Academic Staff of the South-West University "Neofit Rilski".

Curriculum notes:

- 1. The individual educational, research, pedagogical and other types of work from this General curriculum are specified in the individual work plan of each enrolled doctoral student by academic year, indicating details about the relevant horary, modes of implementation and admission, as well as other relevant information.
- 2. The General curriculum reflects all the requirements stipulated in the Higher Education Act, the Law for the Development of Academic Staff in the Republic of Bulgaria, the Regulations for the Implementation of the Law for the Development of Academic Staff in the Republic of Bulgaria and the Internal Rules for the Development of the Academic Staff of the South-West University "Neofit Rilski".
- 3. The curriculum of the doctoral student must provide opportunities for the achievement of the minimum national requirements for the relevant scientific field.
- 4. There are two optional subjects offered, of which the doctoral student must choose one.
 - 4.1. The first optional subject problematizes the development of the relevant historical-philosophical issues in the course of the development of the later history of philosophy.
 - 4.2. The second optional subject problematizes the development of the relevant historical-philosophical issues in contemporary philosophy.

Annotation:

The subject "History of Philosophy" traces the basic and foundational philosophical concepts and ideas generated in the field of the overall historical development of philosophy. Central are the leading theories and systems in the philosophical eras: Antiquity, Middle Ages, Early modern philosophy, XIX-th century philosophy, contemporary philosophy. The PhD

student in "History of Philosophy" develops and demonstrates a comprehensive knowledge of the field of philosophy in its theoretical development and in the specifics of philosophical epochs and works in the theoretical parameters of the foundational philosophical theories of each epoch, including up to the most contemporary trends and direktions.

Course content:

The subject begins with ancient philosophy and traces the cores of historically formed schools and directions in the history of philosophy. The study goes through the major philosophers and their theoretical systems: Plato, Aristotle, Augustine, Thomas Aquinas, Descartes, Locke, Kant, Hegel, Schopenhauer, Nietzsche, Husserl, Heidegger, Sartre, Derrida, Foucault.

Teaching and assessment:

Independent preparation of the doctoral student according to the syllabus of the subject and with consultations with the supervisor. The exam is written on a randomly selected topic from the syllabus. Evaluation criteria: detailed knowledge, comprehensiveness and synopsis of the topic, current connection with the dissertation thesis.

Evaluation criteria: detailed knowledge, comprehensiveness and synopsis of the topic, current connection with the dissertation thesis.
