QUALIFICATION CHARACTERISTICS

I. <u>Basic Characteristics and Educational Objective of the Master's Programme</u>

The Master's degree programme *Social and Cultural Policies in the European Union*, within professional field 3.3 Political Science, is designed for candidates who hold a Bachelor's or Master's degree in disciplines other than Political Science and who wish to prepare for successful professional realization in various sectors of public life. The first two semesters of study provide foundational knowledge in the field of political science, followed by in-depth theoretical and specialized training aligned with the programme's academic focus.

The Master's programme is highly interdisciplinary, offering knowledge in the fields of political science, law, economics, sociology, philosophy, cultural studies, and history. These disciplines are integrated to address the theoretical and practical dimensions of European social and cultural integration. The training focuses on developing specialized theoretical knowledge alongside key competences and practical skills for implementing EU policies in areas such as social cohesion, education, culture, healthcare, and communications. Particular emphasis is placed on the development of the European Union's competences and powers in the social and cultural domains, as well as on its interaction with the national governments of the Member States in these policy areas. The programme examines the main EU institutions involved in these sectors, the relevant legislation, instruments, funds, and mechanisms used for policy coordination and monitoring. It also develops students' skills in critical analysis and policy evaluation. Enhanced foreign language training is included as part of the programme.

Upon successful completion of the program, graduates may also pursue further academic development through doctoral studies.

II. Professional Competence and Realization

Owing to the in-depth theoretical and specialized training provided by the Master's programme, students acquire the knowledge, skills, and competences necessary for applied research activities, as well as the personal qualities required for professional success in today's complex and dynamic world.

Graduates of the programme are qualified to work in central government bodies, local self-government and administrative institutions, cultural organizations, political parties, and trade unions. They may also pursue careers in the private or non-governmental sectors, including roles

involving partnerships with European institutions and participation in the implementation of social and cultural policies within the European Union.

III. Organization and Structure of Study

The master's programme is developed in accordance with the contemporary requirements in theory, practice and research activities in the field of higher education with a particular focus on the social, economic and legal sciences. The programme's curriculum documentation aligns with the latest trends in the development of education in the Republic of Bulgaria, as well as the growing need to deepen training in civic education. Both national and international practice and experience in the respective field have been taken into account in the process of developing it.

The duration of the programme is one academic year (two semesters) and it is intended for candidates who hold a Bachelor's or Master's degree in a field other than Political Science. The curriculum complies with established standards for the professional training of Master's degree holders, ensuring coherence, consistency, and logical progression among the academic disciplines throughout the educational process.

Curriculum:

The Master's programme is structured over four semesters, comprising a total of 3,600 contact hours, equivalent to 120 ECTS credits.

The curriculum includes *compulsory*, *compulsory elective* and *facultative* courses. The **compulsory courses** ensure theoretical foundations and specialized training. The compulsory **elective courses** extend and deepen both theoretical knowledge and subject-specific expertise. What is particular of the **optional courses** is that they allow students to pursue knowledge and skills in other academic disciplines according to students' personal interests. In accordance with Article 2(5) of the Ordinance on State Requirements for Higher Education (SG No. 76/2002), any student may choose optional courses offered by any faculty at SWU "Neofit Rilski," regardless of their home faculty. The total contact hours for optional courses may not exceed 10 % of the programme's overall hours.

To complete the programme, students must either pass a written state examination or successfully defend a Master's thesis. Passing either option awards 15 ECTS credits.

IV. Compliance with the Mission of SWU "Neofit Rilski"

The curriculum and syllabi of the Master's programme in *Social and Cultural Policies in the European Union* are developed in accordance with the mission, educational goals, and research strategies of South-West University "Neofit Rilski" and the Faculty of Philosophy. They reflect the evolving landscape of secondary and higher education in Bulgaria and the country's full integration into the European Union. Built upon established European models, the programme's content is fully comparable to similar offerings at other European universities. At the same time, it incorporates best practices from Bulgarian institutions in Political Science and European Studies, as well as the particular characteristics of the region in which SWU "Neofit Rilski" is located.

Annotation:

The object of analysis of the "Sociology of politics" is the interrelationship between various social needs and activities and political life. Their interdependence and mutual influence is examined. Within the discipline, it is analyzed to what extent change in some spheres of public life leads to change in others. The question arises as to what is the sociological criterion for the effectiveness of a given human activity.

Content of the course:

Nature of political sociology. Socio-political aspects of labor relations. Right to work and trends in labor relations. Discrimination in employment and politics. Political relations as a reflection of economic ones. Economic and political globalization. The role of the state. The penal state. Science, culture and politics. Ideology, religion and politics. Demographic trends and politics. Material needs, health care and politics. Education and politics. Entertainment, recreation, sports and politics. Communications and Politics. Governance and politics.

Annotation:

The initial idea in developing and teaching the course "Comparative Politics" is the idea that under the conditions of globalization politics is also globalized. In this context it the need for knowledge of the unique and the universal in the structure and functioning of the political institutions and how political changes come about is drastically increased. Starting from these considerations, the course is built in response to the principal questions: is it necessary to draw comparisons in politics, what is it which is compared and how is it to be compared, etc. These issues are clarified by presenting both theoretical debates and case studies.

Content of the course:

The main topics covered in the course are: typology of the forms of polity and governance; typology of political regimes, cases, political systems of the United States, Britain, Japan, Russia, France, the interaction between electoral systems and party systems; forms of modernization, etc.

Annotation:

The subject of analysis of the discipline "History of integration processes in Europe" is the main policies and structures of the integration community and the perspectives of pan-European cooperation. The main goal of the course is to acquaint students with the essential legal and political characteristics of partnership with countries and organizations within the Union and beyond. Emphasis is placed on the structures and mechanisms of pan-European cooperation, as well as on the community's strategy for current and future enlargement.

Content of the course:

Post-war cooperation structures. ECSC, EURATOM, EEC. Creation of a European Council and security structures. Transition from coordination to common policies. The crisis of the 70s. Overcoming stagnation. Creation of the European Monetary System. Formation of the concept of the EU. Genscher-Colombo Plan. Steps towards a United Europe. Single European Act (EEA). Extending the scope of the Treaties of Rome. Formation of the Single Internal Market. The four freedoms. Stages of the Economic and Monetary Union (EMU). Convergent criteria. The opening to Eastern Europe. The Stability and Growth Package. From EU 15 to EU 25 and EU 27. Prospects for EU enlargement in the Balkans. Bulgaria in the EU. Post-accession strategy.

The views of individual authors are examined in historical and comparative terms, and their place in the history of political science is highlighted, according to the context of the era in which they were formulated and developed. Basic political ideas and doctrines are covered, with an emphasis on the achievements of European political thought. Special attention is paid to the most influential modern political concepts, as well as to the disclosure of the most important aspects and directions of their application in the real political life of society.

Content of the course:

The history of political ideas as a subject. Main paradigms, doctrines and stages in the development of European political thought. Ancient Greek and Roman political thought. The doctrine of the natural historical origin of the state. The doctrine of the divine origin of the state. Eastern and Western Christian political thought. Political thought during the Renaissance, the Reformation, the New Age and the Enlightenment. The doctrine of the social contract. The political teachings of the 19th and 20th centuries. A socio-historical, liberal and totalitarian doctrine of politics. The state and politics in the postmodern (global) era. The Doctrine of

Universal Liberal Democracy and the End of History. Monocentric and polycentric political models, technocratic and globalization interpretations of 21st-century politics.

Annotation:

The subject of analysis are religions in Europe. Issues related to the evolution of the major world religions on the European continent are discussed. Real trends of modern society are traced - religious pluralism, secularization, religious mobilization, etc. By presenting the results of an empirical sociological study, students get an opportunity for scientific analysis and comparison. The lecture course includes literature that will contribute to the formation of an adequate view and sensitivity to the studied matter. In the lectures, basic categories, concepts and principles are brought out and problematized, which support orientation in the religious dilemmas of modernity. The course assumes a dynamic rather than a fixed definition of religion in modern societies.

Content of the course:

Religions in Europe - introduces students to the issues of religious communities, their main representatives and their distribution in Europe. The aim is to create in students a sense of the relationship between the individual and the community: how different religions with different cultures interact within themselves, with each other and with the larger European society. It is expected that once students have acquired such a perspective and 'understanding' of religions in Europe, they will be able to apply the same way of observation, analysis and theorization to other aspects of life as well as enrich themselves with a wider understanding of religions and their role in modern society. Examples are given of the main representatives of religions in Europe, and their social and political aspects. Controversies and conflicts related to religions are addressed.
