PHILOSOPHY

ECTS credits: 2.0

Annotation: The course aims to reveal students that *Philosophy* is the realm of theoretical reasoning mind and wisdom, as exploring it as a science giving reasons of the pictorial, of its nature and way of existence, as science for nature, inner complexity and inconsistency of cognitive processes as a way of achieving the truth and yet for the meaning of life;

The aim of the course is not simply mastering the material content itself but its deep understanding. Emphasizing the universality of philosophical knowledge, we lead the logical thinking of students to the independent conclusion about the role of philosophy as a methodology of private-scientific and applied knowledge of formation of a particular worldview.

Course content: The place of philosophy in the spiritual culture of mankind. The concept of culture. Clarifying the basic structure of the spiritual culture. Subject specific and language of philosophical knowledge. Relationship of philosophy and other sciences. Philosophical selfreflection. Genesis of philosophy as negation of the empirical knowledge of mythological and religious explanations of the world and man's place in it. Ontological, epistemological, and ethical issues in ancient Greek philosophy. Anthropological ideas of Socrates, Plato and Aristotle.Middle Ages. Philosophy of scholasticism. Possible solutions: God and Reason. St. Augustine and Thomas Aguinas. The philosophy of the Renaissance. Priority of Reason, based on the achievement of natural science and the development of practical activities of man. Materialistic sensualism of John Locke and the subjective idealism of George. Berkeley and David Hume - XVII century. Rationalist tradition in philosophy in modern history. XVII c., XVIII c., XIX c. The problem of method - Deckard, Bacon, Spinoza; Rationalism and humanism of French philosophy in XVIII c. German classical philosophy - Kant, Hegel, Feuerbach; Radical coup d'etat in the philosophy of Karl Marx and Friedrich Engels. The creation of dialectical materialism and the materialist conception of history. Revival of Socrates's ideas. Philosophy of man. Schopenhauer, Nietzsche, Shpengler. Existence and thinking. The pictorial as purely idyllic existence and as available idyllic existence. The problem of finite and infinite. Matter and its basic properties, movement, time, space, reflection and information. Consciousness and spiritual activities of man. Contemplation. Thinking. Language. Imagination and creativity. Consciousness and subconsciousness. Truth. Error. Delusion. Lie. Objectivity and subjectivity of truth. Absoluteness and relativity of truth. Concreteness of truth. Criteria for authenticity of knowledge. Society and its history as an object of philosophical knowledge. The basic structure of society. Dialectics of objective and subjective in human activity. History as a natural process. Historical necessity and chance. Probability in the historical process. Necessity and freedom.

Course organization and assessment: The lecture course on *Philosophy* takes place in the traditionally approved way by using different audio-visual aids, videos.

The exam is written considering the ongoing evaluations during the semester. The test consists of 8-10 questions, including basic concepts, mechanisms, diagrams, descriptions, etc. The ongoing assessment is performed by evaluating assignments on theoretical issues, conduct of independent studies, participation in role-playing games and 1-2 tests on predefined topics from a questionnaire.

Annotation: The course disusses the principlesin business and the mechanisms for their implementation, issues in management, economic policy, disputes in theory and inconsistencies in practice. The principles of macroeconomics, microeconomics and some important current economic issues are exposed consistently. The coursefocuses on the problems of the market system and state regulation, classical and Keynesian Theories of Employment, supply, demand and consumer behavior, main market models, as well as on agriculture, cities, and labor market. The course aims at providing systematic knowledge on the key issues of the economy and clarifying the nature of the market system based on the scientific concepts at the end of XX century.

Course content: General theoretical basis of the market economy. Motivations of business entities; Economic models. Economic structures and interactions.

Course organization and assessment: The lecture course on *Economics* takes place in the traditionally approved way by using different audio-visual aids, videos.

Continuous assessment is based through tests on predefined topics of the researched material, and by evaluating students' assignments, and participation in discussions. The final exam is written. It consists of 8-10 questions. The grade is based on the continuous assessment and the final written exam applying predefined criteria.

GENERAL AND DEVELOPMENTAL PSYCHOLOGY

Annotation: Psychology is one of the fundamental disciplines in the preparation of students. In this course, knowledge of general psychology and age psychology is given. The lecture course on the discipline "General and Age Psychology" introduces students to basic problems of psychology as a specific science. Emphasis is placed on the basic categories in psychology such as: "psyche", "consciousness", "activity", "behaviour". The genesis and development of the main mental phenomena and their characteristics during different ages are clarified; the psychological characterization of the age periods is made; the main factors for the development are clarified. Ontogenetic development is tracked throughout the life cycle.

Students receive information about the patterns of development and functioning of the psyche in normal and abnormal conditions.

The scientific information that students acquire from the field of general and age psychology is necessary for professional training and their future realization as specialists.

When developing the different age periods, emphasis is placed on the peculiarities of the development and formation of the personality of children, adolescents and adults.

In the cognitive aspect, the following content modules are included:

- 1) Historical-methodological problems of general and age psychology. The specificity of the science of psychology. The basic concepts of general and age psychology are clarified.
- 2) Theoretical problems and theories of development;

Objectives of the "General and Development Psychology" course:

Students should acquire a certain system of theoretical knowledge from the field of general psychology and age psychology, interpret them in accordance with the modern requirements of speech therapy science, acquire practical skills for working with persons of different ages and with different psychological characteristics, form an attitude for social - pedagogical activity with psychological determination.

Expected results:

On a cognitive-motivational level: students learn and make sense of basic psychological knowledge (including categories, theories and concepts) in the field of general psychology and age psychology. To be able to analyze psychological information. To realize that their success in practice depends on their psychological preparation.

At the competency level: students should be able to use and apply their psychological knowledge, use psychological concepts competently, be able to adjust their behavior according to the age of the persons they work with, communicate professionally and adequately with the persons they work with.

Content of the course: Science Psychology. Brief historical overview (main schools and trends). Subject, tasks, meaning. the concepts of "Psyche. Consciousness. Activity'. Classification of mental phenomena. Methods of psychological research. The problem of human development: nature, aspects, theories and factors. Age periodization and periods. Basic concepts describing mental development: crisis, sensitive period, etc. Basic theories of development: Theory of the psychosexual stages of development according to Z. Freud; J. Piaget's theory of cognitive development; E. Erikson's theory of psychosocial development. Kohlberg's theory of moral development. Prenatal development. Newborn period. Baby age. Early childhood. Preschool childhood (3-6). Middle childhood (6-12). Early adolescence and late adolescence. Psychology of youth. Psychology of middle adulthood. Psychology of old

age. Abnormal development and behavior - aggressiveness. Communication. Assertive behavior.

Learning technology and evaluation: The evaluation of the learning results is in accordance with Ordinance No. 21 of the Ministry of Education and Science of 30.09.2004 - regarding the accumulation and transfer of credits. All assessments are based on written assignments. The final grade for the course "General and Age Psychology" is formed by evaluating the students' written answers to two questions from the syllabus, and taking into account the results of the current control.

Annotation: The course is aimed at improving the digital competencies of students according to their future realization. After completing the course, students should be able to: apply basic principles and applications of information technology in the relevant professional field; work with modern word processing tools; data processing with spreasheets; present information to the public through computer presentation systems.

Course content: Introduction; Computer System; Software; Operating systems; Copyrights and licenses in IT; Application software – word processing, spreadsheets, presentations; Multimedia formats; Internet services; Computer security – computer viruses and antivirus software

Course organization and assessment: The lectures are presented with a video projector while seminars are conducted in a computer lab with Internet access. During the lectures students are given assignments, which shall be evaluated by the assistant professor. The learning materials are provided in e-learning environment based on Moodle at www.e-learning.swu.bg during the semester students will be evaluated in two control practical works — word processing and spreadsheets and one simple project in MS Power Point.

The final evaluation/grade is formed on the basis of the ongoing evaluation and the final exam-test-in-elearning environment..

Only students whose assessment of the current control is not lower than the average (3.00) should be allowed to take the final written exam. The ratio between ongoing evaluation and final test is 50% - for ongoing evaluation and 50% for final test.

Annotation: The course encompasses the whole 1-year period of studies and aims at the practical acquisition of English at levels A1-A2 according to the European Language Framework and includes the two basic areas: lexis and grammar and the fourskills: reading, writing, listening and speaking. The aimed levels of language competence serve as a basis for the development and use of teaching materials and assessmenttests covering the two areas and the four skills.

Course content: Tenses. Questions; Present tenses; Past tenses; Much/ many. Some/ any. A few, a little, a lot of; Articles; Verb patterns; Future forms; Comparatives and superlatives; Synonyms and antonyms; Present Perfect; Adverbs, word pairs; Time clauses; Passives; Past Perfect; Reported statements.

Course organization and assessment: The ESL course lasts two semesters and students use original textbooks and workbooks (Headway – Student's Book and Workbook). The acquisition of ESL knowledge ischeckedthrough tests, essays, etc., as well as speaking exercises (discussions, stories). There are lessons for mastering vocabulary in the field of social work. For the needs of students majoring in Social Work, there are training classes, which provide students withcomprehensive knowledge ofspecialized vocabulary and terminology. Extramural activities include written assignments. At the end of each semester, students should take a final test. The final markpresents the average of the marks from the final test, the mid-term tests and extracurricular work of the students.

ANATOMY AND PHYSIOLOGY

Annotation: The program introduces the structure and basic functions of the child and the principles of physiologic regulation. In detail is considered the structure of the nervous system as a prerequisite to explain and understand the important vital functions - reflexive activity, emotions, motivation, regulation of alertness and sleep. Their implementation has a direct effect on higher nervous activity and higher cortical functions —the integrative nature of the nervous system. The awareness in anatomy and physiology should serve as a basis for the study of General Hygiene, for easy control of psychology, and more targeted interpretation of the social impact.

The course aims to provide fundamental training in studying the shape and structure of the human body and its normal development.

Course content: Introduction; Cells and tissues; Physiology of excitation; Spinal and celebrum; Reflexive activity of the nervous system; Autonomic nervous system; Sensory organs; Locomotory system; Blood - morphology and function; Cardiovascular system; Respiratory system; Digestive system; Metabolism and water; Skin and thermoregulation; Genitourinary system and reproductive system; Endocrine system.

Course organization and assessment: The lecture course takes place in the traditionally approved way by using different audio-visual aids, videos. The practical exercises are conducted primarily through the use of atlases, schemes, sketches and videos. The final exam is written. The ongoing assessment is based on tests on predefined topics from the studied material, and on evaluation of assignments in line with each intended theme and participation in discussions at the demonstrations.

BASICS OF SOCIAL WORK WITH PROFESSIONAL ETHICS

Annotation: The course in *Basics of Social Work with Professional Ethics* is introductory and essential for the study of the problems of social activity, social work, and social policy. In it the basic concepts, approaches, and methods of social work, protection and support, are being examined; as well as the connections between them and social administration, policy, and management.

During the course the development of social work, its theoretical schools and directions, and its problems and perspectives for development are being examined. The emphasis is on the problems, methodology, and methods of social work, its objects and subjects; as well as on social problems and the approaches, methods, and means to solve them. The students will also study the types of protection and support while working with individuals, families, and groups.

Course content: The discipline aims to teach the students a system of basic knowledge and skills for social activity in its two main directions – social work – social protection and support, and social administration.

The lectures will teach the students the basic information for the areas, the regulatory base, organization, and management of social work in the country, to underline and explain its elements; and on this basis to describe in more detail the different elements and sub-systems of the social system for protection of people and families. The greatest attention will be paid to the immediate social work (social support and protection of unemployed, disabled, and children at risk) – protection and support.

The goal of the seminars and practical classes is to actively meet the students with the general and particular characteristics of social work and mainly – of social protection and support. The

methods, means, and ways for social support while working with poor, helpless, unemployed, disabled, children at risk, part-time workers, and others; will be discussed.

Course organization and assessment: The lecture course uses a complex, system-wide approach, which analyzes the general and particular of social work, its positive and negative characteristics. The students will build up a critical attitude towards the development and realization of social work.

In the course, the students get a current assessment through test and presented theoretical works. The course ends with a written examination - a test, which includes 12 questions, of a previously set conspectus. The criteria, in which a mark is given, are: punctuality, clarity, and precision in the representation of the scientific information.

Annotation: The purpose of this teaching course is to introduce students to the scientific theoretical foundations of Social Pedagogy, the basic concepts, approaches and methods of social-pedagogical work, and the specifics of social-pedagogical work in various contexts.

Course content: Emergence and historical development of Social Pedagogy; The subject and object of Social Pedagogy. Terminology; Objectives, functions and scope of Social Pedagogy; Socialization, social learning and social education; Methodology and research methods of Social Pedagogy; Approaches and methods for social-pedagogical work; Specifics of the social-pedagogical work in schools. Functions of the pedagogical advisor; Social-pedagogical work with children with deviant and delinquent behavior; Social-pedagogical work with families; Lifelong learning; Professional ethics and profile of the social pedagogue.

Course organization and assessment: The course is conducted using contemporary methods of teaching and learning, such as multimedia presentation, video, role-play, case study, debate, and so on. The seminars aim to broaden and enrich students' knowledge through self-study of literature, case studies, debating.

The forms of evaluation are formative assessment and final written exam. The formative assessment is held by evaluating self-developed theses, essays, and 1-2 written tests.

Annotation: This training course foresees questions related to hygiene and health requirements, rules and control of ambient air, water, soil, food, and labor. Attention is drawn also on the contaminants of the biosphere, and the diseasesthey cause. In view of the fact that social services are inherently humanitarian, there is an indirect relationship with the majority of other subjects. The course aims to familiarize students with human's life development, life span, work, and lifestyle.

Course content: Hygiene and prophylaxis; Biosphere; Hygiene of ambient air; Hygiene of water and urban water supply; Hygiene of soil; Hygiene of urban settlements; Hygiene of prevention, social and specialized establishments; Personal hygiene; Hygiene of nutrition; Occupational hygiene; Epidemiology.

Course organization and assessment: The lecture course takes place in the traditionally approved way by using different audio-visual aids, videos. The practical exercises are conducted primarily through regular visits of childcare centers and the local Hygiene and Epidemiology Inspectorate, and discussions of various documents. The final exam is written and consists of 8-10 questions. The ongoing assessment is basedon taking class tests, evaluating students' assignments/projects and participation in discussions at the demonstrations.

Annotation: This teaching course forms the theoretical basis and the specific requirements of social work with representatives of ethno-cultural minority communities. The course aims to provide students with specific training including, primarily, basic knowledge about sociocultural characteristics of ethnic communities in the country, methods and forms of social work with them, and introduction to the concepts of cultural competence, anti-oppressive and anti-discrimination social work. Teaching is focused on the current research in the field and aims to form knowledge and skills through critical reflection and self-reflection.

Course content: Basic concepts in social work with ethnic communities; Anti-oppressive and anti-discrimination social work; Socio-demographic and ethnocultural characteristics of the Roma population in Bulgaria: demographic structure, social status, cultural identity; Socialization/ enculturation of Roma children: specificity and guidelines for effective practice; Specifics of refugees and migrants in Bulgaria: legal and institutional framework; Case work with refugees and asylum seekers; Working in a multidisciplinary team; Specifics of working with unaccompanied minors; Basic forms and methods of social work with ethnocultural

Annotation: Demographics and Statistics is a mandatory course included in the BA programme "Social Activities". Students are introduced to the elements of descriptive statistics, the methods for testing hypotheses, the study of dependencies and the analysis of time series and their application in the study of socio-economic processes. The course lasts one semester and is based on the knowledge of statistics and IT /MS-Excel/, acquired during secondary school education. The proposed educational content has a bearing on all courses requiring analysis of empirical data sets. The extramural activity under this course includes presenting a term paper, working in the library and using a computer.

Course content: Main tasks of mathematical statistics. Random sampling. Types of statistical indicators. Data and presentation of data. Frequency distributions. Descriptive statistics. Measures of central tendency. Measures of distraction. /MS EXCEL/. Probability. Random events. Random variables. Basic theoretical distributions. Scores – consistency, unbiasedness, efficiency. Distribution of the mean in cases of known and unknown variance. Central limit theorem. Fisher theorem. Corollaries. Sample size. Confidence intervals. Confidence intervals for the mean, the variance and the probability of "success". /MS EXCEL/. Statistical hypotheses. Errors. Hypothesis testing for the mean and the variance of the population. Testing of hypotheses on the probability of "success". /MS EXCEL/. Testing of hypotheses on the type of the distribution function. Analysis of dependencies – correlation, linear regression. /MS EXCEL/ANOVA. /MS EXCEL/. Time series. Key demographics. /MS EXCEL/. Analysis of statistical information. /EUROSTAT/.

Course organization and assessment: Mid-term assessment is achieved during seminars through the semester by means of course tasks (30% of the final grade). The course ends with a written exam on the studied material, according to the attached questionnaire (70% of the final grade). In case of receiving a poor grade at the exam, students may retake the exam while still retaining the grade from the course tasks assessment. Students prepare for the exam on the basis of the material taught during lectures and seminars and on the basis of the primary

scientific literature sources. Students may also use materials referred to in the additional literature as well as other sources treating of the relevant material.

Some common morphological changes and major pathogenetic mechanisms of emergence, development and outcome of diseases are discussed. Along with the fundamental knowledge the course foucuses on important social aspects, especially on diseases that cause permanent changes and modify/distractformer social status of the patient.

The knowledge gained during the training has an interdisciplinary character and the main goal is to use it as a base for studying both medical and other subjects with a social focus.

Course content: Introduction to pathology; Study of diseases; General etiology and pathogenesis of diseases; Etiologic factors; Reactivity and resistance of the organism; Immunity and allergies; Violation metabolism; Violation in peripheral circulation; inflammation; Fever; Restorative processes. Regeneration. Tumors; Pathology of blood, Respiratory pathology; Pathology of the cardiovascular system; Pathology of the liver and kidneys; Shock - types, mechanism.

Course organization and assessment: Basic knowledge is provided during lectures.

The exam is written considering the ongoing evaluations during the semester. The test consists of 8-10 questions, including basic concepts, mechanisms, diagrams, descriptions, etc. The ongoing assessment is performed by evaluating assignments on theoretical issues, conduct of independent studies, participation in role-playing games and 1-2 tests on predefined themes from the foreseen material.

Annotation: The discipline "Basics of Law" gives the fundamental legal concepts of the different branches of law in the Bulgarian legal system. The course explains the historical

genesis of the law as a regulatory system of the public relations. The students study the basic principles for organization and functioning of the political institutions. In this regard, the students are provided a detailed review of the formation of the government authorities and their interactions. It emphasis on the basic legal concepts of the public and private law.

Course content: Origin and development of law. Legal system of the Republic of Bulgaria. Subjects of law. Legal norm. Legal acts. Subjective rights and legal obligations. Legal facts. Presumption and fiction. Legal relationship. Offense. Legal liability. System of state bodies. National Assembly. President. Council of Ministers. Constitutional Court. Judiciary. Administrative act. Administrative violation. Administrative-criminal liability. Legal transaction. Representation. Right to property.

Course organization and assessment: Teaching is conducted through lectures. They include discussions and debates on current issues, both theoretically and practically, research and discussion of the Bulgarian legislation, solving of cases, preparation of reports and writing of term papers. The requirements for the semester are regular attendance of the classes, implementation of the assigned tasks and participation in the teamwork. The knowledge of the students is assessed by regular tests during the semester, as the assessment of the results achieved during the course of study is in accordance with Regulation No. 21 of the Ministry of Education and Science from 30.09.2004 on the application of the system for accumulation and transfer of credits.

Annotation: The course on *Neurology* has an aim to familiarize students with the main methods and diagnostics in neurology as well as to allow them to learn typical features of the most common diseases in the nervous system leading to deficits - motor, sensory and coordination. Students will be introduced to the social side of the neurological diseases in detail, also to the "on time" diagnostics and methods for solving the accompanying social problems.

The accent of the lectures and exercises is on neurological diseases leading to severe disability – paralysis, speech and mental disorders. An algorithm is formed on managing patients with this kind of diseases.

Contents of the course: Introduction in neurology - subject, contents, parts of neurology. Functional anatomy and physiology of the nervous system. Neurological examination. Higher nervous activity. Interpretation of the main investigations in neurology. Cerebrovascular diseases. Headache – diagnostics and treatment. Epilepsy and sleep disorders. Dementia. Parkinson's disease and other neurodegenerative disorders. Inflammatory and traumatic diseases of the nervous system. Back pain and lower back pain, diseases of the peripheral nervous system. Vertigo and other disorders of the vestibular system. The influence of alcohol and other intoxications of the nervous system. Pediatric neurology. Neuro-oncology and the main principles of neurorehabilitation. Social aspects of neurological diseases.

Course organization and assessment: The referred themes are studied in relevance of their specific nature and in all of them are used multimedia and computer configuration.

Exercises – the stated topics, in the program of the course, are discussed and are consistent with the aims and tasks of it and their practical usage.

A test is the main form of examination and grading of students. Their knowledge and skills will be graded by the six-point system.

Testing procedures are: current control – it is implemented during the lectures and exercises; exam – the course is finished with a test, which includes 30 questions from questionnaire given in advance. The grading criteria are: accuracy, clarity, precision in the presentation of the scientific information.

Personal property of the spouses. Origin. Adoption. Parental rights and responsibilities. Allowence. Divorce. Custody and Guardianship. Definition of inheritance, heir, heritage. Inheritance by law. Inheritance by will. Acceptance and waiver. Relations regarding inheritance. Partition.

Courseorganizationandassessment: The course is conducted using multiple diagrams and sketches to illustrate examples from practice. The teaching methods are lectures, discussions, role games, presentations, and papers.

The evaluation of the results achieved in the training process is consistent with the requirements of Regulation No. 21 by the Ministry of Education and Science from September 30^{-th}, 2004 for implementation of a system for credit accumulation and transfer. The course ends with a final exam in the form of a written test and includes 12 questions, covering the entire study material.

The constant movement between different social constellations and the delineation of various social strata lead to the acquisition and practice of specific "skills of the mind," which are indispensable to every modern science of society. The lecture course extends over two semesters and includes 30 hours of lectures and 15 hours of seminar exercises.

The objectives of the course are as follows:

- 1. To trace the "becoming" of distinct social lifeworlds and the formation of sociological doctrines within the broader process of the constitution of sociology as a scientific discipline. The aim is to present in systematic form the emergence and development of sociological thought and sociology as a science.
- **2.** To identify fundamental principles, major systems of sociological thinking, and key thematic problem areas of sociology.
- **3.** To introduce students into the semantic space of sociological science, enabling them to naturally internalize the essential categories, principles, and modes of sociological reasoning interwoven into the lecture material.
- **4.** To substantiate the polyparadigmatic character of modern sociology. The reconstruction of the constellation of social worlds that constitute the subject matter of the discipline serves as a distinctive "invitation" for students to engage with sociology.
- 5. To familiarize students with a broad corpus of literature—both classical and contemporary. The course also highlights interpretative frameworks and modes of analysis of sociological texts, particularly in relation to the pressing issues of contemporary society.

As an object of regulation are considered different aspects of an individual's life - his work, health, education, family development, etc.

Students are supposed to have thorough knowledge of theory and practice in Bulgaria and abroad concerning the implementation of various social policies.

Course content: Social policy - practice and science. Functions and object of social policy. Demographic processes and social policy. Social Security - a social policy objective. Right to social security. Social risks. General and professional social risks. Pensions. Social assistance. Policy towards people with disabilities. Social and political aspects of labor. Right to work. Labor discrimination and social policies. Trends in social equality.

Social policy in respect of Employment. Working hours. Unemployment and social policy. The right to safe and healthy working environment. Social policy on income and poverty. Family social policy. Child Protection. Health care social policy. Social policy and education. Corporate social policy. The Social policy of the European Union.

Course organization and assessment: The lecture course is conducted in the traditionally established manner, making extensive use of diagrams and sketches for illustration. A variety of interactive methods are widely employed, including mini-lectures, discussions, student debates, role-playing exercises, and others.

The seminar sessions aim to expand and enrich the knowledge acquired during lectures through independent study of literary sources and the formulation of students' own arguments on specific issues. They encourage independent research activity and contribute to strengthening students' positive self-assessment.

During the course, continuous assessment of students' knowledge is carried out in the form of tests and/or control assignments, theoretical essays, coursework, and other tasks.

Annotation: The auditorium occupation consists of 30 classes (practical exercises). During the classes the students are studying 1)spelling, grammar and punctuation rules of the Bulgarian literary language as well as 2) characteristics of students' scientifically written texts and afterwards taking tests and solving language cases, creating plans of their own scientific texts on individually set topics. The student's extramural activity consists of independent work in the library; homework (solving language tests and creating student scientific texts); consultations with the professors; test preparation; written development of reports, essays or coursework.

The course main objective is to build skills among students to express themselves properly in creating written and spoken language. It will enable them to enrich their overall language skills, thus filling the gaps of knowledge in this area.

During the classes students are guided how to write and structure properly their research papers and then to argue and defend their theses in public.

Course content: Paragraphing. Entitling. Capitalizing. Formal and administrative style. Hyphenation. Commas and full stops. Dashes and quotation marks. Colons and semi-colons. Ya – E mutation rules. The definite article in the oral and the written mode of Modern Bulgarian.

Syntactic coordination. Pronunciation rules. Functional styles. Scientific style. Language characteristics of scientific text.

Course organization and assessment: The primary objective of the course "Written and Spoken Culture" is to enable students to express themselves correctly in both written and oral forms. This will allow them to enrich their overall linguistic competence and address existing gaps in their knowledge in this field. To achieve this, the course relies primarily on the application of interactive teaching and learning methods.

The assessment from continuous evaluation is based on the following criteria:

- attendance during practical sessions;
- active participation in class (demonstrating understanding of linguistic norms and the ability to accurately resolve language-related problems);
- results from the mid-term language test (a passing grade is considered any result above "Fail (2)," i.e., performance above 40% of the required knowledge);
- regular and high-quality completion of independent assignments (demonstrating knowledge of theoretical concepts and the ability to apply them in practice).

At the end of the course, students take a final examination in the form of a written test.

In the discipline, the students will form the basic skills for team work, with emphasis on the specific of work in multidisciplinary teams, realized in social establishments with different groups of people and their families.

Contents of the discipline: The discipline aims to teach the students a basic system of practical knowledge and skills for the work in a team, which are in the basis of formation of new knowledge and competences.

The content and structure of the practical course through different actual problems and formulated structural tasks, aim to create the maximum possibilities to stimulate the individual and research work of the students.

Course organization and assessment: The practical classes aim to form a set of understandings and skills for the work in a team by encouraging research work, assisting to heighten the assertiveness and positive self-assessment of the students.

The classes are held in chosen for the task social establishments, where students can observe, in real environment, work in a team; they are also held in auditoriums, where by the use of

documents, materials, and other sources are made posters, which uncover the essence, goal, tasks, principles, and values while working in a team. During the classes the students form knowledge and skills for the work in a team by entering, of each individual student, into a psycho-dramatic role on previously given cases, then reports are created on the cases.

The course ends with a written examination – a test, which includes 12 questions, of a previously set conspectus. The criteria, in which a mark is given, are: punctuality, clarity, and precision in the representation of the scientific information.

Annotation: The course Labour and Employment Law aims to offer to students the necessary knowledge on the basic principles, concepts and institutions of the Labour and Employment Law. The object of study is the applicable labour and insurance law of the Republic of Bulgaria. Its importance is determined by the rank of the wage labour in modern society, the vital importance of relations arising from participation in labour and occurred based on their social security relationships, as well as their management. Enforcement of labour and social security law occupies an important place in practice of education in social work experts such as managers, employees in government employment, social assistance, social security, health insurance and others. Therefore, the course of Labour and Employment Lawis very important for the students' preparation in the Bachelor program of Social Work.

Course content: By teaching the course on "Labour and Employment Law" is aimed to familiarize the students with basic problems of legal regulation of public relations in connection with the provision of manpower by the employee to the employer concerning issues related to the formation, existence, implementation and termination of employment as well as those related to material support of citizens expressed in the provision of material resources to meet their and their family members' needs in the form of cash benefits, pensions, allowances and other specific objects of use when they have fallen into a state of incapacity due to specific reasons - illness, accident, occupational disease, maternity, old age, death, unemployment, etc. In the course content "Labour and Employment Law" are included issues related to employment contract, its content, types of employment contract and termination. Discussed are institutes of labour law as working time, holidays, vacations. To acquire knowledge in the field of insurance law to the curriculum are added questions about social security of exercising persons in social risks and related to their occurrence insurance benefits to which the insured are entitled.

Course organization and assessment: The course is delivered in the traditionally established format, making use of various audiovisual tools and video materials. The seminar sessions are conducted primarily through interactive methods, including the use of diagrams, video materials, problem-solving of situational tasks, group discussions, case study analysis, and literature review on pre-assigned topics.

The semester grade is determined on the basis of both in-class and out-of-class activities, taking into account the results from tests and written assignments. The final examination is written and conducted in the form of a test.

Annotation: The course in "Clinical Psychology" is essential for the education of students majoring in "Social Activities". In it the nature and paradigm of clinical psychology, its problems, methods, methodology, and technology are being examined; as well as the approaches, principles, methods, and means that are used in the scientific direction.

The goal of the course is to familiarize the students, future social workers, with the basic problems of the science; its subject – "the psychic processes and conditions"; "the individual and interpersonal particularities"; "socio-psychological phenomena", and its object – all individuals that face with "difficulties" in the process of "adaptation and self-realization" in live; as well as the connected with them "physical, social, and spiritual conditions", concerning, directly or indirectly, the work of the helping specialists.

Course content: The discipline aims to teach the students a system of basic knowledge for clinical psychology, needed of the helping specialist in the process of providing sociopsychological support.

The lectures will give the students basic information for the essence of "psychic disorders – and psychic aspects of somatic disorders – illnesses", as well as its other activity directed to: "the increase of psychic resources and possibilities for adaptation" of people; "the harmonization of psychological development"; "care for health"; "prevention"; "psychological rehabilitation". With the seminars it aims to actively meet the students with the general and particular characteristics of clinical psychology. The activities of a clinical psychologist and their connections with the work of helping specialists, the social workers, will be discussed.

Course organization and assessment: During the lectures and seminars a didactical and system-wide approach is used, by analyzing the general and particular in the assistive activities, its components, objects, approaches, principles, methods, means, goals, functions, and tasks. Methodological and technological attitude towards the nature and contents of clinical psychology is being build up in the students.

In the course the students get a current assessment through test and presented theoretical works. The course ends with a written examination – a test, which includes 12 questions, of a previously set conspectus. The criteria, in which a mark is given, are punctuality, clarity, and precision in the representation of the scientific information.

Annotation: In the *Pediatrics* course of an expanded specialized training of students for social work with children is aimed. The program includes introduction to the most common acute and chronic diseases due to the fact that these patients often require prolonged and purposeful social care. A wider acquaintance with the epidemic and infectious diseases is also planned owing to the fact that some of them are defined as "typical" for children. parasitic diseases and opportunities for first aid in emergency and urgent conditions are discussed in special topics. The main intentions of pediatrics training are to upgrade and integrate knowledge in all scientific disciplines (from anatomy and physiology to those relating to the methods and organization of social work, etc.) With pediatric, to supplement the fundamental training.

Course content: The course aims to draw the attention of students, future social workers with children to the problems and prospects of child healthcare in Bulgaria, to highlight the importance of the social problems of medicine and child healthcare, to explore the place and role of medico-social and social activities with children in health promotion and wider personal and social prevention.

The tasks of the course are:

- to outline the subject of pediatrics, the social, the preventive and the curative purposes;
- to emphasize the dynamics in birth rates, infant mortality, and outline the importance of morbidity and its structure;
- to make the future social workers empathetic to the general demographic and health problems, as well as overall morbidity and its structure, knowing that these issues, albeit indirectly are linked to the activity of future specialists;
- to provide knowledge of the principal damage in diseases of the muscles;
- to contribute to the establishment of a healthy lifestyle;
- provide knowledge about the classification of diseases of the respiratory system; to know the reasons and the main clinical features of multiple malformations;
- to provide knowledge about the main diseases such as rheumatism, diabetes, tuberculosis. Special attention is paid to disability in childhood and the impact on the child's body and the reasons and the main clinical features of multiple malformations; to provide basic theoretical knowledge of the most common cases requiring first aid and prove the principles of conduct for these emergencies.

Course organization and assessment: In lectures and practical exercises a comprehensive, system-wide approach to analyzing the public and private child health, its positive and negative characteristics is used. Students build a critical attitude to the pediatrics as a science. In the process of learning students receive current assessment of presented theoretical work. The course ends with a written exam - a test that in which 12 questions from a predefined syllabus are included. The criteria according to which the questions are assessed: accuracy, clarity and precision in the presentation of scientific information.

Annotation: The course "Andragogy" is an elective discipline from the first group, targeted towards the students majoring in *Social Work*. The course covers the requirements for theoretical knowledge and practical skills for social work with adults, set in the qualification characteristics of the major.

In the course the historical development of Andragogy as a science, the theoretical schools and directions, its problems and perspectives for development are being examined. Emphasis is placed on the problems, methodology, and methods of Andragogy; its objects and subjects; as well as the "andragogical model" and "cycle" of work.

Course content: The discipline aims to teach the students a system of basic knowledge and skills for Andragogy "as a science of education of adults".

With the lectures it aims to meet the students with: the essence and fundamental areas of Andragogy; the modern trends for education and communication, socialization and resocialization of adult humans; it also aims to forms skills for: observation, cause and effect analysis, evaluation of the vital cycles and crisis, through which adults pass, which is the basis for the development of a basic practical skills for social work with adults.

During the practical classes the students form knowledge and skills for the development of the "andragogical model" and "cycle" of education of adults, which are the foundation for formation of new knowledge and competences.

Course organization and assessment: The lecture course is conducted in the traditionally established method with the use of many materials for visualization. The lecture, discussion, student debate, business games, and other educational methods are overlapping during the lectures.

The practical classes aim to develop the knowledge gained in the lecture course through independent research of literary sources, giving of personal arguments on certain questions. The classes endorse individual research, and contribute to increase the assertiveness and positive self-assessment of the students.

In the course the students get a current assessment through test and presented theoretical works. The course ends with a written examination - a test, which includes 12 questions, of a previously set conspectus. The criteria, in which a mark is given, are: punctuality, clarity, and precision in the representation of the scientific information.

Annotation: Geriatrics (from the Greek: geron – old man, and iatreia – treatment) is the science concerned with the diseases of elderly and aged persons, including their diagnosis, characteristic course, treatment, and methods of social rehabilitation. The scope of geriatrics encompasses both diseases that begin in earlier stages of life and specific gerontological conditions. Geriatrics primarily addresses problems within internal medicine, orthopedics, neurology, and psychiatry, making it an inherently interdisciplinary field.

In contrast, Gerontology is the science that studies the processes of aging in all their aspects. Geriatrics must in no way be confused with palliative medicine, which aims to support individuals in the terminal stage of incurable illnesses to die in a dignified manner. Geriatrics, by contrast, is devoted to enabling elderly and very old persons to live a better quality of life. The adequate study of geriatrics within social work education in Europe has been identified by the WHO, the UN, the Council of Europe, and the European Parliament as an essential goal and as a critical component of comprehensive health and social care for the elderly. The growing predominance of chronic diseases among older adults, particularly among the oldest segments

of the population, exerts enormous influence on the demand for medical assistance and long-term care. Consequently, there is an undeniable need for sufficiently numerous and appropriately trained professionals in social work.

Course content: The course objective is to give students knowledge about general biological and medical-social aspects of aging and advanced clinical approaches in care of old people, which will enable students to acquire the competencies required for the implementation of professional health care with older patients, according to the modern quality standards. Students are provided practical skills and knowledge to communicate and take care of old people.

Course organization and assessment: Lectures - the referred themes are studied in relevance of their specific nature and in all of them are used multimedia and computer configuration. Seminars - The topics in the program are reviewed and put into practice. A written exam/ test is the main form of examination and grading. Students' knowledge and skills will be graded by the six-point system.

Testing procedures are: current control – it is implemented during the lectures and exercises; exam – the course is finished with a written exam, which includes test, theoretical questions, practical tasks.

The course concentrates on knowledge for the methodology, as well as the methods of social management of social organizations.

By the use of the complex system-wide approach, and analyzing if the general and particular of social management, their positive and negative characteristics, the students will form a critical attitude towards its realization in the public and privet sectors.

Course content: The aim of the lecture course in "Basics of Social Management" is to teach the students majoring in "Social Activities" the theoretical knowledge for management, including social management; the place and the role of the social organization; the place and role of the administration of the social organization; the place and role of management in the social organization; the place and role of RP in social organization; the general and particular elements of the administrative system in the social area and its sub-system - for social support, social aid, unemployment and others.

The goal of the seminars is to meet the students with the general and particular characteristics of social management, to discuss the guidelines for theoretical and real development and improvement of the social management.

Course organization and assessment: In the lectures and seminars a theoretical and practical approach will be used, in order to analyze the general and particular in social management, its components, objects, subjects, approaches, methods, principles, means, goals, functions, and tasks. The students will be building up methodological and technological attitude towards the essence and content of social management.

In the course the students get a current assessment through test and presented theoretical works. The course ends with a written examination - a test, which includes 12 questions, of a previously set conspectus. The criteria, in which a mark is given, are: punctuality, clarity, and precision in the representation of the scientific information.

Abstract: The training course in "Communication Disorders" aims to introduce students the types of communication disorders and their impact on the quality of life of people of different age groups. The training includes an explanation of the communication process - its linguistic and extralinguistic components. Future social workers study the causes and symptoms of impaired ability to receive, send, process, and understand verbal, nonverbal, and graphic symbol systems. Special attention is paid to the social aspects of speech and language pathology. Future social workers are introduced to the International Classification of Functioning, Disability and Health: ICF and its application to people with communication disorders. Students acquire knowledge of recognizing disorders of verbal and non-verbal communication and skills to work in a team with the speech and language therapist and other professionals (medical doctor, psychologist, physiotherapist, occupational therapist, etc.) who participate in the processes of prevention, assessment, therapy, socialization and improvement the quality of life of persons with speech and language pathology.

Competences that the student should have after completing the course of study in the discipline "Communication disorders":

- Referring persons with communication disorders for interventions to relevant professionals (speech and language therapist, medical doctor, psychologist, physiotherapist, etc.)
- Providing support or advocacy for clients with speech and language pathology
- Providing support or advocacy in assessing and coordinating the provision of specialized services for persons with communication disorders
- To be able to determine the status of persons with communication disorders who should be assisted under various state programs or schemes for support and accessibility to services in order to improve or rehabilitate the capacity for social functioning and improve the quality of life
- Supporting persons with communication disorders and their families, couples and relatives by connecting with support groups and self-help groups

Course content: Communication - nature and types; Types of communication disorders; The International Classification of Functioning, Disability and Health: ICF and its application to persons with communication disorders; Articulation disorders; Communication disorders in craniofacial injuries; Fluency disorders; Voice disorders; Laryngectomy; Language disorders in children; Neurogenic communication disorders - dysarthria and aphasia; Disorders of Reading and Writing; Communication disorders due to hearing impairment and visual impairment; Communication disorders in emotional-behavioral disorders and mental illnesses; Multiple disorders; Voice and communication changes in transgender people; Application of complementary and alternative communication; Application of robotic and assistive technologies for people with communication disorders; Counseling and advising for persons with communication disorders; For each communication disorder, the role of the social worker in the team approach in working with persons with speech and language pathology is considered.

Course organization and assessment: In the lecture course and seminar sessions, a variety of interactive teaching methods are employed, such as reflective techniques, brainstorming, discussions and debates, the use of clinical materials, video resources, specialized equipment, software, and others.

For independent study, students are expected to:

- Develop a discussion topic assigned in advance by the lecturer;
- Solve case studies;
- Prepare papers with a scientific and practical focus;
- Prepare for test-based examinations.

PSYCHIATRY

Annotation: The course examinesany pathological changes in mental processes, with a focus on studying the basic disorders of the various fields of the psychic apparatus, the general laws of occurence and some features of the course of mental health disorders in different stages of human life cycle.

Students should acquire knowledge about basic aspects of general psychopathology and key features of socially significant mental disorders, as well as skills for working in mental health teams for people with mental disorders.

Course content: The course consists of two modules: general psychopathology and disorders of mental health. The first module explores various disorders of mental functions and methods of investigation in psychiatry. The second module focuses on the etiology, pathogenesis and classification of mental disorders. Students are introduced to the main clinical characteristics and approaches for the treatment of both organic and symptomatic mental disorders;

schizophrenic; affective disorders; anxiety disorders; disorders associated with substance abuse; mental retardation; disorders of eating behavior; personality disorders. The final lecture presents the organization of the psychiatric care and the role of social worker in the different structures.

Course organization and assessment: The lecture course takes place in the traditionally approved way by using different audio-visual aids, videos and if possible with a demonstration of cases.

The seminars are held in the form of semi-structured discussions with the moderating role of the lecturer and include discussions of different case studies, video analysis and discussion of survey results.

The practical sessions, if possible, are carried out in a daycare center and sheltered home for people with mental disabilities, a daycare center for children and adults with intellectual and physical disabilities. The aim is to enable students to build a therapeutic relationship with patients and then be able to perform their assigned tasks - working with documentation of the disease and wording in certain cases (schizophrenic, alcoholic disease. Addictions, dementia, affective disorders psychosomatic disorders, organic brain disorders).

There is an examination in the form of a written test covering the entire material taught at the end of the training course.

Annotation: The course aims to build understanding of the family as a group with its defined roles, functions, priorities and problems - in the context of the ecosystem approach and the theory of family life (stages of family development); to reveal the interconnection of family members; to propose models for family diagnostics based on understanding of family interactions; research, evaluation, intervention and planning of care; to communicate with institutions whose help it needs the family; building partnerships with semeystvoto when working on different social occasions.

This course on *Family Communication and Adaptation* offers knowledge about the phenomena of communication and adaptation and their specific deployment in the context of the family. There are discussions concerning the relevant concepts for helping the family as a group; framework for group behavior and group dynamics, which is useful for case work with individual families.

Course content: Through the course students become aware of the basic concepts of: theories of the family, different family types, methods of study of the family, the process of communication in the family; family crisis; family violence, foster families; practical work with families.

Course organization and assessment: The lecture course is delivered through modern interactive teaching and learning methods designed to foster students' active engagement. These include multimedia presentations, video materials, role-playing exercises, case study development, student debates, and more. Practical sessions are conducted both through the development of case studies in the classroom and within real working environments.

Continuous assessment during the course is carried out through project proposals, advertising materials, reports, presentations, essays, and other assignments. The final examination is written in the form of a test and covers material from both the lectures and seminar sessions. It consists of open-ended and closed-ended questions, each with a predetermined weight.

Annotation: The training course on *Social Communication and Adaptation* is based on two key social work concepts - adaptation and communication, as well as teamwork and supervision. Adaptation is considered in two main aspects, as a fundamental characteristic of living beings, including the individual and in the aspect of its disorder. Communication is viewed in its direct and through competent manifestation, as well as its theoretical and practical plan.

Students should acquire knowledge and skills for effective communication required for the social worker and the organization of work - in the formation and teamwork and interaction with other departments to ensure complete customer service.

Course content: the theory of communication; axioms of communication; adaptation as a process; case management in social practice; work in a multidisciplinary team.

Course organization and assessment: The lecture course takes place in the traditionally approved way by using different audio-visual aids, videos. During the seminars students dispute different theoretical overviews to a given topic, discuss case studies and share personal experience.

The practical exercises include class discussions, evaluation of case studies, video analysis and evaluation of horizontal and vertical communication between social institutions.

The course ends with either a written exam (test) or defense of a course project and taking into account ongoing evaluations during the semester. There is an examination in the form of a written test covering the entire material taught at the end of the training course.

PSYCHOLOGICAL COUNSELLING AND CRISIS INTERVENTION

Annotation: The lecture is divided into two main modules: psychological counselling and crisis intervention. In the first module are presented the principles and models of psychological counselling and basic skills that are necessary for the consulting practice in social work.

The second module includes the theory of the crisis, the structure and dynamics of the process of crisis intervention and its scope. Particular emphasis is placed on the issue of violence in its various forms and the relevant programs for crisis intervention

The course aims is to equip the students with basic knowledge about basic concepts of psychological counselling and crisis intervention with a view to propose a practical framework for consultation, which can be further developed and adapted according to specific cases in social practice.

Course content: conceptual overview and models of psychological counselling; application areas; crisis intervention, conceptual overview and application areas; specificity of crisis intervention with abused children, attempted suicides; early intervention.

Course organization and assessment: The lecture course takes place in the traditionally approved way by using different audio-visual aids, videos. During the seminars students dispute different theoretical overviews to a given topic, discuss case studies and share personal experience.

The practical exercises include evaluation of case studies and video analysis.

The course ends with either a written exam (test) or defense of a course project and taking into account ongoing evaluations during the semester. There is an examination in the form of a written test covering the entire material taught at the end of the training course.

SOCIAL WORK WITH CHILDREN

Annotation: This lecture course covers the theoretical, normative, methodological and ethical aspects of social work with children. The emphasis is put on the modern concepts of child and childhood, risk, resilience, child-centered approach, family-oriented practice, specific groups of children at risk and disadvantage, and more. Both the preventive and the interventional

aspects of social work with children are substantiated. Special attention is paid to personal and professional qualities and ethical principles and norms for working with children.

Course content: Concepts for child and childhood; Theories of the development in childhood; The child and their rights; Child protection and welfare system in Bulgaria; The child in social work; Child and risk; Risk Assessment. Risk and protective factors; Resilience; Assessment of children's needs; Case work with a child at risk; The child in the context of the family. Work with the family; Specifics of working with children's groups; Social work with children, victims of violence and neglect; Specifics of support in residential services; Social work with children with disabilities; Social work with children in conflict with the law; Quality and efficiency of social services in the community for children; Contemporary challenges to social work with children; Professional competence of the social worker to work with children. Attitudes and professional skills for working with children; Code of ethics for those working with children.

Course organization and assessment: The lecture course is conducted using modern teaching and learning methods such as multimedia presentations, video materials, role-playing exercises, case study development, student debates, and others.

The forms of assessment include continuous evaluation and final examinations. The examination in the discipline "Social Work with Children" takes place in the fifth semester and is conducted in written form. During the course, students complete two written assignments, which constitute the main component of the continuous assessment.

SOCIAL WORK WITH ADULT AND PEOPLE WITH DISABILITIES IN THE SYSTEM OF WELFARE SERVICES

Annotation: In the course in *Social Medicine* the new guidelines and trends for the preparation of different specialties in the disciplines of public health and healthcare are stated aswellasto other professionals, which by increasing their knowledge and skills in the field of public health can contribute to reducing preventable diseases and disabilities. The attention of master students majoring in the "Social studies" will be directed primarily at clarifyng the subject and the methodology of the social medicine, its integrative character, complex research policy, social health factors, contemporary concepts of individual and public health, especially risk factors of health.

Course content: The aim of the course is to focus the students' attention to group and public healthcare, to highlight the significance of social problems of medicine and healthcare, to investigate place and role of medico-social and social activities in health promotion and wider personal and social prevention.

The tasks of the course are:

- to propose a methodology for studying the indicators of public health and the health needs of the population, social determinants of health and disease;
- to investigate health status of the population, demographic processes and risk factors of health:
- to contribute to the establishment of a healthy lifestyle;
- to highlight medical and social problems of the active population.

Course organization and assessment In the lectures and practical exercises is used a comprehensive, system-wide approach to analyzing the public and private public health, its positive and negative characteristics. Students build critical attitude to developing and realizing social medicine as a science.

In the process of learning students receive ongoing assessment of a presented theoretical work. The course ends with a written exam - a test of 12 questions from a predefined syllabus are included. The criteria according to which the questions are assessed: accuracy, clarity and precision in the presentation of scientific information.

Annotation: The training involves studyingthe basic aspects of mental health, psychological treatment, psychotherapy and mental hygiene, which are closely related to social work.

The main topics are divided into two main modules. The first module uses a three-dimensional framework to present the key activities and programs in the field of psychological treatment throughout individual's life stages. The second module presents the basic aspects of psychotherapy and necessary skills to apply psychotherapeutic approaches in the different fields of social work.

During the course, students gain valuable knowledge of psychological treatment and psychotherapy and skills for working with individuals, groups and families.

Course content: The aim of the course is to draw students' attention to group and public health, to emphasize the significance of the social dimensions of medicine and healthcare, and to examine the place and role of medico-social and social activities in health promotion and in broad-based individual and community prevention.

The objectives of the course are to:

- provide a methodology for studying public health indicators, population health needs, and the social determinants of health and illness;
- examine the health status of the population, demographic processes, and health risk factors;
- contribute to the promotion of a healthy lifestyle;
- highlight the medico-social issues affecting the working-age population.

Course organization and assessment: The lecture course is delivered in the traditionally established manner, with the use of numerous diagrams and illustrations for visualization. Minilectures, discussions, student debates, business (simulation) games, and other interactive methods are also widely employed.

The seminar sessions are designed to expand and enrich the knowledge acquired during lectures through independent study of literature sources and the formulation of students' own arguments on specific issues. They encourage independent research activity, foster greater assertiveness, and contribute to strengthening students' positive self-assessment.

Continuous assessment of students' knowledge is carried out through tests and/or written assignments, coursework, theoretical essays, and other forms of evaluation. The final examination is written, in the form of a test, and covers material from both the lectures and seminars. It consists of open-ended and closed-ended questions, each assigned a specific weight indicated in advance.

Annotation: The course aims to broaden students' specialized training in social work with children. In this regard, it acquaints students with the relevant part of the current legislation that

is primarily directed towards the protection of children, their rights, and their legitimate interests.

The main goal of the course is to educate and prepare professionals capable of ensuring that every child's needs are met. Of primary importance for the child is to grow up in a family environment, or at least in conditions close to a family setting; to receive good upbringing and education; to develop in a healthy environment; to learn to respect and observe the generally established norms and rules of social conduct; and, most importantly, to be safeguarded against various forms of criminal encroachment.

The legal framework of the discipline includes the study of national and international legal instruments that provide for the protection of the child in various aspects of social life. International legal instruments ratified by the National Assembly of the Republic of Bulgaria, in accordance with Article 4 of the Constitution, have binding force on all subjects within the country and take precedence over domestic legislation.

Among the central aims of the course is to introduce students to the issues concerning juvenile offenders and the special measures taken by the state for their correction and re-education. In this way, the fundamental preparation of future social workers is complemented and expanded in scope.

Course content: Historical development of the idea of human rights. The rights of the child as a system. The rights of the child in international legal instruments. General characteristics of the Child Protection Act. Principles of child protection. Child rights under the Child Protection Act. Child protection bodies under the Child Protection Act. Child protection measures under the Child Protection Act. Child protection measures in a family environment. Child placement outside the family. Special care for children with disabilities. Special protection. Police protection of children and specialized protection in public places. Significance of age for criminal responsibility - criteria for dividing children into minors and juveniles. Commissions for combating antisocial behavior of minors and juveniles - types (central and local), composition and powers. Types of educational measures under the Child Protection Act. Procedure for imposing measures related to the placement of a minor or juvenile in specialized boarding schools. Appeal. Procedure for imposing lighter measures by local KBPPMN. Appeal. Children's pedagogical rooms - organization, functions and interaction with other institutions and organizations. Social and pedagogical boarding schools - order and conditions for accommodation and organization of activities. Educational boarding schools - organization of activities and order and conditions for accommodation. Centers for temporary accommodation of minors and juveniles. Shelters for unattended children. Public educators. Special regime for criminally liable minors under the Criminal Code of the Republic of Bulgaria - exemption from criminal liability. Purpose and types of punishments provided for minors. Exemption of a minor from serving an imposed punishment - Art. 64 Criminal Code. Other legal grounds for mitigating the criminal law regime for criminally liable minors - in connection with the application of the provisions on conditional sentencing and early release. Enhanced criminal law protection of minors and juveniles from crimes committed against them.

Course organization and assessment: The lecture course is delivered in the traditionally established manner of academic lectures. Presentations are used for the delivery of all topics. The teaching process also makes use of standard templates and forms approved by regulatory acts. Time is allocated for questions and discussions on current issues, and both interactive and discussion-based teaching methods are employed.

In the seminar sessions, selected issues are discussed, formulated within the theme of each exercise. Students are expected to prepare in advance by locating and reviewing specific provisions of current legislation relevant to the seminar topic. Case studies are also solved as part of the seminars. Discussion methods are predominantly applied.

The semester grade is based on both classroom and out-of-class activities, taking into account the evaluation of mandatory and supplementary assignments completed during the semester. The final examination is written and consists of a test with 21 questions, both open-ended and closed-ended. The maximum number of points for each question is indicated on the test.

Both clinical etiological and psychosocial aspects of common disorders of mental health in childhood and adolescenceare also discussed. Students should acquire knowledge of basic mental disorders and the peculiarities of age crises

in childhood and adolescence; principles of treatment, as well as the ability to identify different psychopathological acts within different age periods, and work with children and families.

Course content: Theories of Development; General Psychopathology of Child Development; Research Methods; Etiology, Pathogenesis and Classification of Mental Disorders in Childhood; Autism Spectrum Disorders; Mental Retardation, Emotional and Behavioral Disorders; Sleep Disorders; Behavioral Disorders, Addictions.

Course organization and assessment: The course is conducted in traditionally approved way by using different audio-visual aids, videos.

The practical classes are carried out in accredited centers for practical training through presentations and work on cases.

The course ends with either a written exam (test) or defense of a course project and taking into account the ongoing evaluations during the semester. There is an examination in the form of a written test covering the entire material taught at the end of the training course.

The module Sexual education is determined by the circumstances that sexual education still occurs predominantly spontaneously; regulation in this area is mainly in the way of social units and stereotypes and in society dominated by underestimation of the importance of the problematic area of sexual activity in personal and social view.

The students should acquire knowledge of basic theoretical and practical methods in sexology and characteristics of sexuality in different ages and methods of sexual education. Thus, the studentsbroaden their professional competence and their suitability to solve personal and social problems related to their principal work duties.

Course content: Sexology as a subject; Main categories of sexuality; The problem "sexual dimorphism"; Levels of sexuality; Stages of sexual contact; Hierarchical signs to assess sexuality; Health assessment of sexual behavior; Nature of sexual education; Criteria for sexual education; Problems of modern society; Sexual education as a practice.

Using variety of arts with curative intent; the emphasis in the curriculum is on the cathartic effect of perception and creation of works of art.

Students have the opportunity to learn about the variety of art therapeutic methods and approaches, and to get a major focus on professional competence for adequate art therapy for a limited number of patients.

Course content: Therapeutic efficacy of works of arts and artistic creativity; Suggestion and treatment. Perception of speech and music. Suggestion, suggestibility. Hypnosis. Nature of hypnosis. Research and hypotheses about hypnosis; Psychoanalysis and Psychotherapy. Characteristics of psychoanalysis. Art and psychoanalysis. Sleep and dreams; Characteristics of Gestalt therapy, Analytic conversational therapy, Non-analytical colloquial therapy, Behavioural therapy, Expressive therapy, Painting therapy; Psychodrama.

Course organization and assessment: In addition to the lecture component, delivered through multimedia presentations, the course places strong emphasis on demonstration and practical activities. Interactive methods and techniques are primarily employed. The learning process is

supported with literature, as well as photographic and video materials. Students are positioned as researchers and experimenters. Research-practical tasks are carried out in groups, which fosters the development of essential skills for their future professional practice.

Annotation: The course in *Occupational Therapy* discusses the issues of the emergence of occupational therapy, its history both in Bulgaria and abroad, different types of occupational therapy and its dosage, personnel and equipment, techniques, occupational therapy in different diseases and some results of its application.

The goal of "Occupational Therapy" is to help accelerate and strengthen the healing process with all available means and methods.

Course content: Origin, history and nature of occupational therapy; Types of occupational therapy; Occupational therapy and its dosage; Staff, equipment and techniques used in occupational therapy; Occupational therapy in various diseases.

Course organization and assessment: The lecture course in Occupational Therapy takes place in the traditionally approved way by using different audio-visual aids, videos.

Conducted are seminars with exercises primarily through the use of diagrams, videos, solving case studies, group discussions.

The final exam is written considering the ongoing evaluations during the semester. The test consists of 8-10 questions, including basic concepts, mechanisms, diagrams, descriptions, etc. The ongoing assessment is performed by evaluating assignments on theoretical issues, conduct of independent studies, participation in role-playing games and 1-2 tests on predefined themes from a predefined syllabus.

The aim of the course in *Complex Rehabilitation* is to present and utilize the students with basic knowledge in this area.

Course content: Introduction to the course; Anatomic and physiological peculiarities of children; Functional changes, rehabilitation and medical rehabilitation of the cardiovascular system of children; Primary arterial hypertension; Respiratory diseases, bronchopulmonary diseases, asthmatic bronchitis and others.

Course organization and assessment: The lectures are conducted in the traditionally established manner, incorporating multimedia presentations of the course material and interactive teaching methods. The format also includes discussions and the expression of personal opinions and positions on the topics taught.

For continuous assessment (seminar exercises and results from out-of-class work), the following components are evaluated:

Task complexity (very complex, complex, simple, very simple);

Scope of completion (complete, partial, incomplete);

Systematic use of knowledge required for the task (task self-contained; requiring limited knowledge from one field; requiring complex knowledge from multiple fields);

Understanding – personal opinion and interpretation of the assigned task and achieved results (comprehensive interpretation, fragmentary interpretation, lack of interpretation).

Annotation: The course "Social work in medical institutions" presents scientific-theoretical and practical approaches to the implementation of complex and integrated care that meets the needs of the individual and the community through effective social work in medical institutions. The aim is to systematize and expand students' knowledge of applying the bio-psycho-social approach in caring for the health and well-being of individuals and their families.

Course content: The lecture course includes three modules. The first module analyzes the main conceptual frameworks of the integrated approach and care and the cross-sectoral approach, as well as the regulatory framework that regulates them. The second module focuses on the concept of medical social work, transdisciplinary teams and quality and effectiveness standards. The third module focuses on the main areas of application of medical social work: children, the adults and the elderly with various medical and social problems.

Course organization and assessment: The lecture course is conducted with the help of modern interactive methods of teaching and learning, aimed at motivating the active role of students through the use of multimedia presentations, videos, role games, case work, student debates, etc.

The practical exercises are conducted both by developing various cases and in a real work environment.

The assessment includes the results of the examination assessment and the current control. The exam is written and includes 12 questions / definitions, norms, rules, processes, etc./. The current control is carried out by evaluating tests, theoretical and practical development on a predetermined topic and developing a case with practical application.

The main goal of the course is to acquaint students with the terminology, the personality of convicts, their communities and groups, the corrective forms of interaction with persons deprived of liberty, the existing system of rehabilitation and resocialization and the main sociopedagogical paradigms. in this area.

Course content: Historical data on theorigination of prisons and the development of penitentiary science in Bulgaria. Legal bases of social work in places of deprivation of liberty. Nature and goals of social work in penitentiary institutions. Peculiarities of the object of influence in the places of deprivation of liberty. Factors determining the specifics of social work in prisons. Procedural approaches and methods for individual social work in penitentiary institutions. Case work. The interview as a research method in social work with prisoners. Rationalization of free time in places of imprisonment - cultural and sports activities. Preparing convicts for life in freedom.

Course organization and assessment: The lecture course is conducted in the traditionally established way with the use of various audio-visual aids, multimedia presentations, videos, role-playing games, case studies and video materials. The exam is in a written format, taking into account the current grades during the semester. The control during the semester is carried out through the implementation of quizzes on pre-set topics of the studied material.

Content: Assumptions and theoretical foundations of anti-oppressive practice in social work. Concepts in anti-oppressive social work. Principles of anti-oppressive practice in social work. Models of anti-oppressive social work. Understanding intersectionality. Power and power distances in the perspective of anti-oppressive social work. Ethics of anti-oppressive practice in social work. Cultural humility in the context of anti-oppressive social work. Working with groups in an anti-oppressive way. Principles of research in the context of anti-oppressive social work. Anti-oppressive practice skills.

Organization of instruction and assessment: The teaching course is conducted by using traditional and contemporary methods of teaching and learning: lecture, multimedia presentation, discussion, video films, etc. Instructor's own research and practical experience is also used in the process of teaching The practical exercises aim to expand and enrich the students' knowledge and to build skills for work in a way that takes into account and addresses the power imbalances in practice by keeping a reflective diary, role-playing games, solving cases, etc. They encourage students' own research, contribute to increasing their confidence and positive self-esteem. Teaching focuses on

contemporary practices in this field and aims to form knowledge and skills through critical reflection and self-reflection.

Content: Refugees and identity. The current refugee situation in Bulgaria. Concept of refugees and migrants in the context of international legal and national documents. Institutional and regulatory framework for integration of refugees and migrants. Inclusive policies for refugees and migrants. Ethical aspects of working with refugees and migrants. Casework with refugees and migrants. Group social work with refugees and migrants. Vulnerable groups of refugees. Social work with vulnerable groups of refugees. Specifics of working with unaccompanied minors. Coordination in working with refugees and migrants. Multidisciplinary team. The role of the UN High Commissioner for Refugees in Bulgaria. Non - governmental organizations for work with refugees and migrants. The social worker as a subject in the work with refugees and migrants - professional attitudes and skills.

Organization of instruction and assessment: The lecture course is conducted through modern interactive teaching and learning methods, including multimedia presentations, case discussions, debates, and student-led discussions. Practical sessions focus on the development of skills through role-playing exercises, work on specific case studies, discussions, and, where possible, observation of casework in a real professional environment.

Continuous assessment of students' knowledge is carried out through coursework, theoretical essays, and other assignments. The final examination is written, in the form of a test, and covers material from both lectures and practical sessions. It consists of open-ended and closed-ended questions, each assigned a different weight indicated in advance.

The aim of the training is to offer knowledge about the nature, models and principles of psychosocial rehabilitation and the possibilities for reintegration of people with severe mental illness in their natural environments. Emphasis is placed on the key role of the social worker in the context of the mental health services offered in the community.

Course content: Nascence of psychosocial rehabilitation - a brief retrospective. Philosophy and goals of PSR. Basic principles of PSR. Models of psychosocial rehabilitation. Mental health policies. Severe mental illness and its effects on social skills. Quality of life. Resilience. Needs assessment - models and tools. Individual care plan. Case formulation. Case management.

Social skills training. Integrated social and health services. Multidisciplinary teams and supervision in psychosocial rehabilitation. Organization of mental health services in the community - modern trends and good practices.

Course organization and assessment: Variety of teaching strategies and methods are used: multimedia presentations, videos and if possible - demonstration of cases. During the seminars, students discuss different theoretical analysis and results from the studies to a given topic, discuss case studies, share personal experience. The use of video analysis is to stimulate critical thinking, intellectual creativity, and sharing of knowledge and skills with and through the class. The current control is carried out by evaluating independently developed theoretical topics, annotated bibliography on certain topics of the lecture course, case studies, test.

The course offers a theoretical interpretation of violence as a phenomenon, its individual types and varieties;a comprehensive assessment of violence and its consequences through an appropriate set of criteria; skills for developing an adequate strategy for professional behavior in the study and assessment of cases of violence, as well as in developing programs for its prevention. Given the interdisciplinary nature of violence, the program covers aspects of law, sociology, psychology, medicine and social work. The main goal is to offer knowledge and skills for understanding and recognizing the different types of violence, risk factors and developing prevention programs. Course content is structured on an interdisciplinary perspective that will enable students to recognize different types of violence violence and be able to examine not only effective preventive approaches and strategies, but also interventions.

Course content: Terminology and definition of violence against children. Current classifications. Risk and protective factors. Resilience. Types of violence and neglect - main features. Cycle of violence. Consequences of experienced violence in childhood Strategic documents in the field of prevention of violence and neglect of children. Modern legislation on prevention of violence against children. Violence prevention - models and approaches. Role of WHO and ISPCAN. Levels of prevention. Coordination mechanism.

Course organization and assessment: Variety of teaching strategies and methods are used: multimedia presentations, videos and if possible - demonstration of cases. During the seminars, students discuss different theoretical analysis and results from the studies to a given topic, discuss case studies, share personal experience. Organization of instruction and assessment: The course is conducted using contemporary methods of teaching and learning, such as multimedia presentation, video, role-play, case study, debate, and so on. The practicum aims to broaden and enrich students' knowledge through self-study of literature, case studies, debating, etc.

The forms of evaluation are formative assessment and final written exam. The ongoing assessment is held by evaluating self-developed cases, role plays, and 1-2 written tests.

The aim of the course is acquiring knowledge about biological, medico-social aspects of endof-life care in different diseases and the contemporary clinical and psychological approaches toward patients. The acquired experience and information will give students capability needed for working with terminal stage patients as professional healthcare givers, to give them psychological help and consultation according to the current standards of medical care. The course forms practical skills, type of communication and caring for the end-of-life patients in students. At the end of the course students will have learnt how to empathize with and care for terminal patients according to the acquired knowledge and skills.

Course content: Aim, subject and range of palliative care. Psychological, social and spiritual aspects of dying. Attitude towards death and dying in different religions: Christianity, Islam, Judaism, Buddhism. The meaning of quality of life in terminal stage patients. Multidisciplinary approach in palliative care. Types of nursing homes and organizations for nursing care. Legal regulations for nursing homes in Bulgaria and countries in the EU. Announcing to patients the truth about their disease. Euthanasia and assisted suicide. The specifics in palliative care for children and their families. Specifics in palliative care for geriatric patients. Care for the families of terminal stage patients. Psychological problems in personnel, working in palliative care. Pathophysiology of pain and it's management.

Course organization and assessment: Lectures - the referred themes are studied in relevance of their specific nature and in all of them are used multimedia and computer configuration. Seminars - The topics in the program are reviewed and put into practice. A written exam/ test is the main form of examination and grading. Students' knowledge and skills will be graded by the six-point system.

Testing procedures are: current control - it is implemented during the lectures and exercises; exam - the course is finished with a written exam, which includes test, theoretical questions, practical tasks.
