# GENERAL AND SOCIAL PSYCHOLOGY

# **Annotation:**

The subject "General and Social Psychology" is studied in the first semester as a compulsory subject in the curricula of master in Psychosocial Rehabilitation.

Objectives of the course "General and Social Psychology": to clarify General and Social Psychology's basic concepts and theories. In this discipline, students study the modern socio-psychological approaches to personality. Students are introduced to various theories about the nature and characteristics of small groups, the characteristics of the masses' behavior, and the crowd. Conflict typology and strategies of behavior in a conflict situation are studied. In the course "General and Social Psychology" are also presented the cognitive processes through which people contact with the flow of information around them. In this discipline, students are introduced to the structure of the psyche, the types of cognitive processes, and some diagnostic methods for examining cognitive deficits.

#### **Course content:**

The course in General and Social Psychology includes the following modules: 1) the process of socialization, socio-psychological theories of personality; 2) social groups, leadership, and social influence; 3) communication, aggression, conflicts, and prosocial behavior; 4) psychological study of cognitive processes and personality.

# **Training and assessment:**

The lecture course is conducted using modern technical means such as multimedia and computer programs. The seminars are conducted through interactive methods. The active independent work on the students' part is expressed in the preparation and presentation of research papers, tests; essays; and case studies.

The evaluation of the students' results is carried out according to the system for transfer and accumulation of credits. The final grade is formed at the end of the course based on the grade received in response to a topic studied in the lecture course, and the grade from the student's extracurricular work.

Grading scale: a six-point grading scale is used, where a grade of excellent 6 is equal to grade A in the European grading system; grade very good 5 is equal to grade B in the European grading system; a score of good 4 is equal to a grade of C in the European grading system; a grade point

average of 3 is equal to grade D in the European grading system; a score of weak 2 is equal to a grade of E in the European grading system.

#### **Course outline:**

The course in *Demographics and Statistics* involves the elements of descriptive statistics, the methods for testing hypotheses, the study of dependencies and the analysis of time series and their application in the study of socio-economic processes. The course lasts one semester and is based on the knowledge of statistics and IT /MS-Excel/ acquired during secondary school education and the BA program. The proposed educational content has a bearing on all courses requiring analysis of empirical data sets. The course aims at raising students' awareness of the nature and the various applications of statistical methods as well as of the possibility of implementing some of these procedures by means of Information Technology tools (MS-Excel, VBA, SPSS, etc) in the study and analysis of demographic processes. The structure and content of the course takes into account the students' knowledge of informatics and statistics, obtained from the relevant courses. The topics in the program have a bearing on all courses that require analysis of empirical data.

# **Course content:**

Upon completing the course students have to be able to:

- use and apply the methods of demographic statistics;
- implement specific applications using various technological means.

# **Course organization and assessment:**

Teaching methods: seminar, discussion, exercises, simulations.

Requirements: Students must have completed a course in Information Technology.

Assessment: term paper -30% of the final grade; written exam test -70% of the final grade.

The course is considered to be successfully completed on receiving at least 50% of the maximum grade result.

#### **Annotation:**

The course "Basics of Social Work" is introductory and fundamental for the study of problems in social activity, social work, and social policy. In it the basic concepts, approaches, and methods of social work, protection, and support are being examined; as well as explaining connections between them and social administration, policy, and management.

The course looks closely in the evolution of social work, theoretical schools and directions, the problems, and the prospects for its development. It is accented on the issues, methodology, and methods of social work, its objects and subjects; as well as social problems and approaches, the methods and means to overcome them. The types of protection and support while working with individuals, families, and groups are examined.

# **Contents of the discipline:**

The discipline's purpose is to teach the students a system of basic knowledge and skills for social activity in its two main areas: social work – protection and support – and social administration.

During the lectures, the students will gain the initial information for the areas, regulatory framework, organization, and administration of social work in the country; its characteristic elements will be highlighted and justified; on this basis, the different parts and subsystems of the social system for protection of people and families will be further described.

With the practical classes, it aims to familiarize the students with the general and particular characteristics of social work mainly – social protection and support, realized practically.

# **Technology of education and assessment:**

During the lectures a complex, system-wide, approach will be used to analyse the general and particular of social work, of its positive and negative characteristics. Critical attitude towards the planning and implementation of social work will be build up in the students.

In the course of study, the students get a current mark from presented theoretical works.

The course end with a written examination - a test - that includes 12 questions from previously handed out summary. The criteria, by which the answers are being assessed, are punctuality, clarity, and precision in the representation of scientific information.

#### **Annotation:**

The discipline "Basics of Law" gives the fundamental legal concepts of the different branches of law in the Bulgarian legal system. The course explains the historical genesis of the law as a regulatory system of the public relations. The students study the basic principles for organization and functioning of the political institutions. In this regard, the students are provided a detailed review of the formation of the government authorities and their interactions. It emphasis on the basic legal concepts of the public and private law.

# Course organization and assessment:

Teaching is conducted through lectures. They include discussions and debates on current issues, both theoretically and practically, research and discussion of the Bulgarian legislation, solving of cases, preparation of reports and writing of term papers. The requirements for the semester are regular attendance of the classes, implementation of the assigned tasks and participation in the teamwork. The knowledge of the students is assessed by regular tests during the semester, as the assessment of the results achieved during the course of study is in accordance with Regulation No. 21 of the Ministry of Education and Science from 30.09.2004 on the application of the system for accumulation and transfer of credits.

#### **Annotation:**

In the course in *Social Medicine* the new guidelines and trends for the preparation of different specialties in the disciplines of public health and healthcare are stated as well as to other professionals, which by increasing their knowledge and skills in the field of public health can contribute to reducing preventable diseases and disabilities. The attention of master students majoring in the "Social studies" will be directed primarily at clarifying the subject and the methodology of the social medicine, its integrative character, complex research policy, social health factors, contemporary concepts of individual and public health, especially risk factors of health.

#### **Course content:**

The aim of the course is to focus the students' attention to group and public healthcare, to highlight the significance of social problems of medicine and healthcare, to investigate place and role of medico-social and social activities in health promotion and wider personal and social prevention. The tasks of the course are:

- to propose a methodology for studying the indicators of public health and the health needs of the population, social determinants of health and disease;
- to investigate health status of the population, demographic processes and risk factors of health:
- to contribute to the establishment of a healthy lifestyle;
- to highlight medical and social problems of the active population.

# **Course organization and assessment:**

In the lectures and practical exercises is used a comprehensive, system-wide approach to analysing the public and private public health, its positive and negative characteristics. Students build critical attitude to developing and realizing social medicine as a science.

In the process of learning students receive ongoing assessment of a presented theoretical work. The course ends with a written exam - a test of 12 questions from a predefined syllabus are included. The criteria according to which the questions are assessed: accuracy, clarity and precision in the presentation of scientific information.

Nature of management. Principles, methods and functions of management. Management, organizational structure and functions of the Ministry of Labor and Social Policy. Agency for Social Assistance. Employment Agency. Nature of social security. Social assistance in Bulgaria. Basic normative documents for work in the social assistance system. Social Assistance Act. Regulations for implementation of the Social Assistance Act. Family Benefits for Children Act. Regulations for the implementation of the Family Benefits for Children Act. Child Protection Act and regulations for its implementation. Specifics of the profession social worker. Definitions and requirements for the profession of social worker. National Health Insurance Fund. Construction and development of the structures of the National Health Insurance Fund and the Regional Health Insurance Funds. Forms of health insurance. Social work in prisons.

# **Course organization and assessment:**

The course is conducted in traditionally approved way by using different audio-visual aids, videos. The practical exercises are held in social welfare services. The exam is written taking into account the ongoing evaluations during the semester.

# **Annotation:**

The course in *Social Policy* examins the combination of social activities regulating social relations in order to monitor equality and inequality in society. Different communities and institutions - the state, political parties, NGOs, businesses, individual citizens, international institutions and organizations are subject to this regulation. As an object of regulation are considered different aspects of an individual's life - his work, health, education, family development, etc.

Students are supposed to have thorough knowledge of theory and practice in Bulgaria and abroad concerning the implementation of various social policies.

# **Course content:**

Social policy - practice and science. Functions and object of social policy. Demographic processes and social policy. Social Security - a social policy objective. Right to social security. Social risks. General and professional social risks. Pensions. Social assistance. Policy towards people with disabilities. Social and political aspects of labor. Right to work. Labor discrimination and social policies. Trends in social equality.

Social policy in respect of Employment. Working hours. Unemployment and social policy. The right to safe and healthy working environment. Social policy on income and poverty. Family social policy. Child Protection. Health care social policy. Social policy and education. Corporate social policy. The Social policy of the European Union.

# **Course organization and assessment:**

The course is conducted using multiple diagrams, sketches, videos, case studies, role playing games, etc. The teaching methods are lectures, discussions, role games, multimedia, and papers. The exam is written considering the ongoing evaluations during the semester. The test consists of 8-10 questions, including basic concepts, mechanisms, diagrams, descriptions, etc. The ongoing assessment is performed by evaluating assignments on theoretical issues, conducting of independent studies, participation in role-playing games.

The program provides for acquaintance with the general concepts of methodology and methods of social work as well as with the basic theoretical and practical formulations of the specifics of the methods in different types of social work. The training course clarifies its essence the specifics of social work as a profession, the main methods, principles and approaches that are applied in the work with individuals and groups.

#### **Course content:**

Individual social work. Essence. Types of skills and relationships. Specifics of the individual phases of individual social work. Group social work. Requirements and rules for group social work. Types and types of groups and their formation. Work phases in group work. People with disabilities like main contingent in social assistance. Classification of disability.

Requirements for determining damage. Assistive technologies when working with people with disabilities. Specifics of the work of a social worker with people with disabilities.

Social and psychological work with people with disabilities. Forms of socio-psychological work with people with disabilities. Stress and disability. Sport as a method in social work with people with disabilities. Social work with families. Methodology of social work with refugees. Social work for the elderly. Methodology of work with unemployed persons. Methodology of work in occupational therapy and cultural therapy. Methodology of social work in AIDS patients. Project preparation - method in modern social work.

# **Teaching and assessment:**

The course is conducted in traditionally approved way. In teaching use examples from the long-term medical and social practice of the holder of discipline. The independent preparation provides: preparation for exercises on each topic /syllabus; methodologies, etc./; preparation for solving tests and control works; developing topics with theoretical and practical orientation.

The exam is written taking into account ongoing evaluations during the semester.

#### **Annotation:**

The course "General Sociology and Sociology of Labour" is composed of two parts: 1. General sociology enters the terminology and the main structural elements and reflections of sociology and sociological knowledge; 2. Sociology of labour presents those specific sociological trajectories closest to the main issues of the speciality "Psychosocial Rehabilitation". The topics related to labour division, the labour process elements, labour organizational units, corporate culture, labour conflicts, social policy, motivation, attitudes, the cohesion of labour collectives, labour realization, labour migration, and communication in collectives leadership are considered, social norms and deviation, etc. Students study the discipline not as two separate parts, but as an interconnected sociological whole with specific applications. Knowledge is obtained about the basic sociological methods and their application in the sociological research of organizational groups. The course aims to acquire knowledge and skills for sociological argumentation in analyzing social facts in modern society.

#### **Course content:**

The lecture course on "General Sociology and Sociology of Labour" aims to gain in-depth knowledge of students about the theoretical and applied aspects of general sociology and sociology

of labour - classical and modern theories, the structure of sociological knowledge, etc. Particular emphasis is placed on the problems of socialization, social roles, social learning, stereotypes, social conflicts, social inequalities and stratification, etc.

# Training and assessment technology:

The lectures will use a system-wide and specific approach, analyzing the general and the private in the public and business units. Students will develop a methodological attitude to the nature and content of social facts.

In the process of training, students receive an ongoing assessment of presented theoretical and applied projects.

The course ends with a written exam - a test that includes 15 questions from a pre-set syllabus. The criteria according to which the questions are evaluated are accuracy, clarity and precision in presenting scientific information.

#### **Annotation:**

The course Labour and Social Security Law aims to offer to students the necessary knowledge on the basic principles, concepts and institutions of the Labour and Social Security Law. The study is focused upon the applicable labour and insurance law of the Republic of Bulgaria. Its importance is determined by the rank of the wage labour in modern society, the vital importance of relations arising from participation in labour and occurred based on their social security relationships, as well as their management. Enforcement of labour and social security law occupies an important place in practice of education in social work experts such as managers, employees in government employment, social assistance, social security, health insurance and others. Therefore, the course of Labour and Employment Law is very important for the students' preparation in the Master program of Psychosocial Rehabilitation.

# **Course content:**

By teaching the course on "Labour and Social Security Law" is aimed to familiarize the students with basic problems of legal regulation of public relations in connection with the provision of manpower by the employee to the employer concerning issues related to the formation, existence, implementation and termination of employment as well as those related to material support of citizens expressed in the provision of material resources to meet their and their family members' needs in the form of cash benefits, pensions, allowances and other specific objects of use when

they have fallen into a state of incapacity due to specific reasons - illness, accident, occupational disease, maternity, old age, death, unemployment, etc. In the course content "Labour and Social Security Law" are included issues related to employment contract, its content, types of employment contract and termination. Discussed are institutes of labour law as working time, holidays, vacations. To acquire knowledge in the field of insurance law to the curriculum are added questions about social security of exercising persons in social risks and related to their occurrence insurance benefits to which the insured are entitled.

# **Course organization and assessment:**

The lecture course on *Labour and Social Security Law* takes place in the traditionally approved way by using different audio-visual aids, videos. Conducted are seminars with exercises primarily through the use of diagrams, videos, solving case studies, group discussions, case studies, study of literature by a given topic.

In the process of training students receive ongoing evaluation of the presented theoretical developments.

The course ends with a written exam - a test that includes 12 questions from a predefined syllabus.

#### **Annotation:**

The course is one semester and consists of 5 separate units. The first unit emphasises on advanced information search on the Internet and its filtering. The knowledge of searching, which guarantees self-learning and Lifelong Learning, will help students to cope independently with each of the disciplines.

The course introduces the technologies for creating, processing and publication of images, videos and interactive multimedia presentations.

#### **Course content:**

Introduction and basic services on the Internet. Browsers. Browser settings of Google Chrome. Bookmarks (Bookmarks). Search engines. Advanced search for information on the Internet. Some aspects of the graphical Windows operating system and online image editors. The course includes creating interactive, multimedia presentations, videos and publishing them on websites

#### **Annotation:**

The teaching course aims to equip students with a system of knowledge and skills in the technology of social work with children, adults and people with disabilities. The program is divided into two modules: technology of social work with children at risk and technology of social work with vulnerable adults and people with disabilities. The content of the course, its structure, various topical issues, and formulated tasks are designed to create maximum opportunities for strengthening the independent and research work of the students.

#### **Content:**

Concepts, requirements and definitions of social work technology; Types of technological approaches in the work of social worker; Essence of the social casework with children. Group social work with children. Current trends in social work with children.

Essence of the social casework with adults and people with disabilities. Group social work with adults and people with disabilities. Current trends in working with adults and people with disabilities.

#### **Technology of education and assessment:**

The attention of master students majoring in "Psychosocial Rehabilitation" will be aimed primarily at clarifying the idea of the different aspects of the problems of mental health services in the community, the types of social services in the community, structure and methodology of work in mental health services in the community. The course is based on knowledge obtained by courses in psychiatry, psychopathology, psychology and other subjects in the bachelors program. The course aims to introduce students to the values, ideology and politics of community psychiatry. Community psychiatry is examined as a practice that puts the basis on person's attention, its potential for development needs. The course shows how this problem is solved at levels: local service, local and central policy, organization of mental healthcare in the community, development of psychosocial rehabilitation.

#### The tasks of the course:

- be proficient in new perspectives on different aspects of mental health services problems in the community, the types of social services in the community, the structure and methodology of work in mental health services in the community;
- to apply these perspectives in specific instances of dealing with these problems;
- tobe able to assess to create strategies for inclusion in the activities of mental health services in the community themselves;
- to learn the concept of the multidisciplinary team as a mandatory part of psychiatric care in the community, in order to avoid a narrow medical approach;
- to provide knowledge for optimizing procedures for referral to a specialist by establishing clear rules and requirements for providing information in both directions;
- to emphasize the role of the family as a fundamental part of psychosocial rehabilitation process;
- to assimilate the fact that psychosocial rehabilitation, the customer should be considered as a subject and disease as an object.

The course on "Therapeutic behavior" is a general education and basic training of students in "Psycho-social rehabilitation."The course in "Therapeutic behavior" is a necessary part of the education of students studying in the master's program "Psychosocial Rehabilitation", because it is used to obtain knowledge about the nature of the therapeutic environment, therapeutic management and related therapeutic relationship in a new for our country's social service community, such as psycho-social rehabilitation.

The course is based on knowledge obtained by courses in medical disciplines in the bachelor program. Therapeutic behavior has a direct and indirect connection with psychosocial rehabilitation, mental health services in the community and with other social and medical disciplines.

The attention of master students in "Psychosocial rehabilitation" will be aimed mostly at clarifying the idea of building a therapeutic community as the basis of best rehabilitation process in persons with severe mental illness. The course aims to examine the conceptual and practical meaning of the relationship professionals-client at the development of the therapeutic process. To achieve this aims, the course includes a set of skills of the therapeutic situation for the purposes of the distribution of roles in it, for the distribution of responsibilities between professional and client and basic principles of structuring relations in the therapeutic situation, to ensure the achievement of therapeutic goals. Utilization of skills for the creation, development and use of therapeutic relationship, the course includes assignments in which students practice what they have learned in the theoretical part.

# **Contents of the course:**

The therapeutic relationship as socially. Therapeutic situation: definition, nature. Nomination as an opportunity to build a therapeutic relationship: adoption, clarification and redrafting.

Use of the therapeutic framework to build therapeutic relationships, delays, absences unauthorized contacts with professionals. Recognition of anxiety in the therapeutic interview: work with anxiety and build confidence. The lack of development in the course of the therapeutic relationship. Recognizing and dealing with resistance and protecting the client. Failures in the rehabilitation plan as an opportunity for development. Promoting autonomy: unauthorized contacts with similar clients. Teamwork. Creating a therapeutic situation with involuntary client. Use of the procedure for involuntary treatment. Role of targeting and directional professional in building a therapeutic relationship. Work and organizational environment as an element in building a therapeutic relationship. Legal Basis and therapeutic relationships.

# **Teaching and Assessment:**

The course uses a comprehensive, system-wide approach for analyzing the public and private in psychosocial rehabilitation, its positive and negative characteristics. Students build critical attitude to the therapeutic approach, therapeutic relationship, therapeutic relations. The seminars are held in appropriate facilities for practical training support targeted at assimilation of lectures or using authentic documents, materials and more. For each topic the base or materials are specified.

In the process of training students receive ongoing evaluation of presented theoretical work and assignments in the form of multimedia presentations and developed support materials for a user of social service.

The course ends with a written exam - a test that in which 12 questions from a predefined syllabus are included. The criteria according to which the questions are assessed: accuracy, clarity and precision in the presentation of scientific information.

The course in "Case formulation" is a necessary part of the education of students studying in the master's program "Psychosocial Rehabilitation". Formulation of case is the pivotal clinical skills of professionals working in the field of mental health.

The course aims to help students acquire skills to build a case formulation and use of wording as a tool for engaging the customer, achieving therapeutic contract and planning treatment. Special attention is paid the utilization of formulation in order to achieve an overall approach to the client with mental illness and continued in time evaluation of interventions. The course integrates basic concepts of psychodynamic theories looking for the meaning and for the ways that the disease takes place. This facilitates professionals during the creation process, maintenance and use of therapeutic relations to achieve the goals of therapy.

# **Contents of the course:**

Psychiatric case formulation; Psychodynamic formulations; Biological formulations; Behavioral formulations; Biopsychosocial formulation; Convergence of views in case formulation; Writing psychiatric case formulations.

# **Teaching and Assessment:**

The course is conducted in traditionally approved way by using different audio-visual aids, videos. The exercises are held in facilities provided for the purpose (daycare center for psychosocial rehabilitation, sheltered home) or using authentic documents, materials, etc. on the basis on which are prepared role plays and developing studies.

The examination is conducted in writing. During the training, students have one paper test, like the main part of the monitoring.

It is expected to build students' understanding of the need for a holistic approach to planning and offering services, following the needs and strengths of users of mental health services. Case management of mentally ill people requires mediation with institutions and specialists to partner and cooperate in meeting the needs of mentally ill people.

The emphasis is on unifying the efforts of specialists from the helping professions and coordinating the necessary services by offering an individual program of care for each patient. The topics of the criteria and the procedure for inclusion in a care program, the monitoring of their implementation and the discharge from the program are covered. Special focus is placed on planning care for patients with challenging behavior, risk management and working with other professionals in the context of the community.

**A** conceptual review of "case management"; models, approaches and stages; indications for admission to a case coordination program; evaluation, development of an individual therapeutic plan, interventions with an individual client; family interventions; systematic interventions in the community, work in a multidisciplinary team.

The course structure presupposes various forms of teaching: lectures will present any theoretical material, and seminars will master their necessary practical skills. There are also extracurricular activities (demonstrations, case studies), which will provide students with various forms of independent work in the learning process.

The course closely looks at the basic concepts, approaches, and methods of psychosocial work with people and families with severe mental disorder, protection and support of people with disabilities and their families in the practice of mental health care.

# **Contents of the discipline:**

The goal of the course is to familiarize the students with the basic principles and approaches, which are implemented here and abroad. This will be connected with not only general issues of existing patterns; but also how they are implemented here, as well as the possible difficulties in that regard. Special attention will be paid to the imminent social support (methods and methodology), social protection (preventive, through control and imminent), and social aid (benefits and services),

granted to families with members whom have severe mental disorder in the practice of mental health care.

By the seminars the course aims to actively familiarize the students with the general and particular characteristics of social work and mainly – of social protection and support of families with members having severe mental disorder. The methods, resources, and ways of social support in the work with families with members having severe mental disorders in the practice of psychosocial care will be discussed.

# **Technology of education and assessment:**

In the lectures and seminars a complex, system-wide, approach will be used to analyse the general and particular characteristics of social work and support of families with members having severe mental disorders, of it positive and negative characteristics. Critical attitude towards the planning and implementation of social work and social support while working with families having members with severe mental disorders will be thought to the students. In the course of study, the students get a current mark from presented theoretical works. The course end with a written examination – a test – that includes 12 questions from previously handed out summary. The criteria, by which the answers are being assessed, are punctuality, clarity, and precision in the representation of scientific information.

Course in "Leadership in mental health community service" is a necessary part of the education of students studying in the master's program "Psychosocial rehabilitation", because it is used to obtain knowledge at the essence of ethics of the professional behavior and ultimately therapeutic framework in the work with each individual client into a new for our country's social service community, such as psychosocial rehabilitation.

The aim of the course is for students to understand the essence of the development of the service social-therapeutic counseling, maintaining the standards of good practice, ethics of professional behavior and ultimately the therapeutic framework in working with each individual client, requires an organizational culture in which participation and authorship is a basic principle of presence in the organization. Promoting the ability to participate and author in organizations is one of the functions of leadership, which utilizes the human factor for the purposes of the work task and

improving the quality of services in the community. Supporting the leadership process in organizations contributes to staff motivation and reduction of burnout. The development of the clients of the service goes in parallel with the development of the professionals and the professionalism in the specific organization.

Upon successful completion of the course, students should be able to:

- to master new perspectives on various aspects of leadership problems related to the social-therapeutic counseling service;
- to apply these points of view in the specific cases of working with these problems;
- be able to evaluate and create strategies for improving the quality of services on the basis of the acquired knowledge package.

Leadership Theories. Leadership as the subject of study. Identification, symbolization and leadership. Leadership, following and primary task. The need for the study of leadership. Leadership in the context of human organizations. Leadership and organizational culture. Transformational leadership. Learning organization. Leadership team. Course in "Management of mental health community service" is a necessary part of the education of students studying in the master's program "Psychosocial Rehabilitation", because it is used to obtain knowledge about the essence of management in a new for our country social service in the community, such as psycho-social rehabilitation. The course is based on knowledge obtained from the training Fundamentals of Management and Social Management undergraduate program.

The aim of the course is for the students to learn the peculiarities of management in a specific and new social service, psycho-social rehabilitation. To achieve this objective the course includes a range of knowledge about public management, public policy, public strategy, including theory and business management processes in the macro - and meso - subsystems of the social system, and public management, containing management public organizations and their human resources. For acquiring skills for managing mental health services, marketing and follow-on strategies and policies, the course includes assignments in which students practice what they have learned in the theoretical part.

The tasks of the course are:

- to master new perspectives on different aspects of governance, policies and strategies for the development of mental health services in terms of the current requirements in psychosocial rehabilitation
- to build knowledge and skills for the application of those points in the specific case of working with these issues
- to be able to evaluate and create their own strategies for development of mental health services.

#### **Annotation:**

Because severe mental illness impairs a person's ability to meet a wide range of psychosocial and biological needs, ensuring optimal functioning in the community requires the efforts of various professionals to be coordinated and adequate to the needs, resources and life project of the patient. The case coordinator performs this function, as multidisciplinary teamwork is an adequate way to maintain an organizational culture in which participatory management of interactions between different professionals.

The course aims to introduce basic concepts and sensitize students to the group processes that occur during team meetings. These processes contribute to or hinder the performance of work tasks. Understanding them implies the possibility for them to be experienced and a space for their understanding through the theory of groups and group processes. Therefore, the course will be organized on the creation of group situations and their discussion.

#### **Content of the course:**

Team-definitions, main functions and roles. Formation and development of the team. Characteristics of the individual stages. Models. Team meetings - basic rules and procedures. Teamwork efficiency. Barriers to effective teamwork. Modes of team work - the work task and on internal problems. Role of the leader of the team meeting for regime management. State of basic assumption - dependence. State of basic admission - struggle - escape. The use of the team as social protection against anxiety (collusive relationships, rigid rules and boundaries, victimization of the client or family, etc.). Decision making, responsibility, and accountability in multidisciplinary teamwork. Learning in a multidisciplinary team.

# **Course organization and assessment:**

The lecture course is conducted by using traditional and contemporary methods and materials such as different audio-visual aids, videos, and if it is available, with demonstrations of cases.

The independent students' preparation envisages: research and analysis of literature sources, preparation of the annotated bibliography, preparation of tools and conducting research of problems and good practices of teamwork in the field of mental health; development of course work.

The on-going assessment is carried out by assessing of students' individual work/papers on preset topics from the lecture course. The exam is written (test with multiple choice questions) taking into account the current grades during the semester.

Criteria for evaluation of the written works: accuracy of the used terminology, coherence, and logical exposition of the thematic material, correctness in quoting the literary sources.

# **Annotation:**

The exact definition of the concept of communication is the goal of the whole course and gives the boundaries and its subject. The prerequisites that characterize communication as the social behavior of the person are considered.

The current curriculum aims to provide students with knowledge and skills for human communication (verbal and nonverbal) and to acquire basic communication skills related to their future profession as speech therapists.

The training in the discipline aims to help students master the processes through which participants in communication adapt and solve problems arising from social interaction, or defining roles, responsibilities, and norms, as well as resolving disagreements and conflicts. Students are expected to acquire and apply a set of communication skills needed in their immediate speech therapy work as a final learning outcome.

#### **Course content:**

The profession of a social worker and human communication; Development of communication, language, and speech; Social communication; Basic Communication Skills - Effective listening and messaging, asking questions, reflecting, self-disclosing, building and maintaining trust, managing anger, resolving conflicts, negotiating, power and influencing.

# **Teaching and assessment:**

Students' training includes lectures, which are mandatory in order to master the minimum knowledge. In the process of learning in some of the classes, students are divided into small groups and play situations in which they demonstrate basic types of communication skills. The main form of assessment of students' knowledge is the written exam. A test with open and closed questions and reporting of the current control is applied.

#### Annotation:

The course on "Mediation in Conflict Resolution" is designed for students training to work in a dynamic environment of interpersonal communication, such as that of a social worker.

The aim of the course is to familiarize students with the main characteristics and psychological aspects of interpersonal conflicts and the possibility of direct intervention through mediation in their resolution.

The lecture course is aimed at improving the knowledge and professional competencies of students in working with people in direct contacts and conflict situations.

# **Course content:**

Definition of a conflict. Elements of the conflict. Types of conflicts. Dynamics of the conflict. Types of conflict solutions. Steps for constructive conflict resolution. Mediation in overcoming conflicts in the family. Mediation in overcoming ethnic and social conflicts. Mediation in resolving labor conflicts. Competence of the social worker in resolving conflicts.

# **Organization of instruction and assessment:**

The lecture course is conducted using traditional and modern interactive teaching and learning methods, such as: lecture, multimedia presentations, discussion, learning by doing, etc. Results from the lecturer's own research and practical experience are used.

The exam is written, taking into account the current grade during the semester.

# **Annotation:**

The course in "Reproductive Behavior and Demographic Policy" is both general and basic for the training of students in the master's program in "Psychosocial Rehabilitation". The course "Reproductive Behavior and Demographic Policy" is a necessary part of the preparation of students in this specialty, because it provides knowledge about the nature of demographic processes, the factors that determine them and trends in demographic development in Bulgaria.

#### **Course content:**

The aim of the training in the section on reproductive behavior is to inform students with the problems of sexual and reproductive health in different age groups, as well as for people with disabilities. In the sector of demographic policy - to inform students with the main demographic indicators used in the analysis of demographic processes; with the causes and manifestations of the demographic collapse in the country, the socio-economic and other factors influencing the demographic indicators; to provoke the search for and implementation of strategies and models for dealing with the demographic collapse in the country.

# Training and assessment technology:

The lecture course is conducted in the traditionally established way with the use of various audiovisual means, video materials. The exam is written taking into account the current grades during the semester. It is conducted through a test or 8-10 questions, including basic concepts, mechanisms, schemes, descriptions, etc. The current control is carried out by evaluating independently developed theoretical topics, developing individual cases.

#### **Annotation:**

The elective course "Communicative Disorders" is studied within one semester and is designed for students in the master's program in "Psychosocial Rehabilitation".

The aim of the course is for students to acquire knowledge about speech and language pathology and opportunities for providing social services that will lead to improved quality of life and social integration of people with communication disorders.

Students learn about the process of communication and its disordersduring the course. Future professionals consider the classification of speech-language pathology, based on the specifics of the etiology and symptoms. Different types of assistive technologies are considered, which help people with language and speech disorders to communicate independently and to express themselves. Students learn to recognize communication disorders and their impact on the quality of life of those affected and their families. Students study the role of the social worker in the teamwork with persons with language and speech pathology.

At the end of the lecture course students are expected to: be able to recognize the presence of a communication disorder; to be able to refer persons with speech and language pathology to the relevant professionals for consultations, prevention, assessment, therapy; to apply the acquired knowledge and skills to work in a team of professionals in various fields that offer services to improve the health and quality of life of people with communication disorders; to know basic methods and systems for augmentative and alternative communication and assistive technologies supporting communication.

#### **Content:**

Communication and speech-language pathology. Classification of communication disorders. Articulation and orofacial disorders. Voice disorders - work with persons with laryngectomy and tracheostomy. Fluency disorders. Language disorders in children and adults. Neurologically based communication disorders - dysarthria, apraxia, aphasia. Disorders of written communication. Communication disorders due to sensory impairments - hearing and vision. Communication disorders in emotional-behavioral disorders - autism spectrum disorders, attention deficit hyperactivity disorder (ADHD). Teamwork in people with dementia. Swallowing disorders. Voice and communication change in transgender people. Application of augmentative and alternative communication and assistive technologies that support communication.

# **Teaching and assessment:**

In the process of teaching presentations, demonstration of multimedia products and other audiovisual means, discussions are used.

The main form of assessment of students' knowledge is the written exam. A test with open and closed questions and reporting of the current control is applied.

#### **Abstract:**

The subject of this course are the different types of psychological defenses and non-verbal communication in the context of social work. #### Annotation:

The lecture course is conducted in the traditionally established way and is based on the theoretical paradigm of the universal significance of labor and social rehabilitation to improve the quality of life of social sites and people with disabilities. The knowledge in the field of "Labor and social rehabilitation" is necessary for students due to the essential features of their future work with

patients / clients /, elderly people with social problems, with impaired anatomical and physiological functions, as well as with accompanying other somatic disorders.

The course aims to provide fundamental training in a basic direction - labor and social rehabilitation. The content of the lecture course, its structure, the various current problems, the formulated problem tasks aim to create maximum opportunities to activate the self student work.

# **Course content:**

Introduction to the course "Labor and social rehabilitation". Definition of labor and social rehabilitation. Nature and definitions for labor and social rehabilitation. Research on the disability as an object of rehabilitation. Basic directions of research. Systems for assessment of lost working capacity. Rehabilitation and employment. Diseases and disabilities. Terms and concepts in the field of labor and social rehabilitation. International organizations and their role in the development of labor and social rehabilitation. Bodies and organizations in Bulgaria conducting rehabilitation. Labor and social legislation governing the issues of Rehabilitation Professional qualification and retraining of people with disabilities. Evaluation of the effectiveness of rehabilitation measures.

# **Training and assessment technology:**

The lecture course is conducted in the traditionally established way and is based on the theoretical paradigm of the universal significance of labor and social rehabilitation to improve the quality of life of social sites and persons with disabilities. The teaching strategy is built on the classics teaching traditions. The exam is written. It includes 12 questions / definitions, norms, rules, processes, etc./.The final grade takes into account the results of the current control and the grade from the exam.

#### **Annotation:**

Natural disasters like earthquakes, fires, floods etc. are extremely dangerous for people. They arise suddenly, develop fulminantly and strike wide spaces and usually affect a lot of people.

The aims and tasks of the course are students to acquire knowledge about these extreme conditions and to understand their effect on people's daily life and psychological state; what are the reactions of the individual personality and the community as a whole in this kind of situations; the features of Posttraumatic stress disorder and the role of the specialist in dealing with it. Also students are introduced to the main principles for behavior during earthquakes, fires, floods, hurricanes etc.;

organizing and conducting rescue operation in regions of disasters; methods and ways of giving first aid to injured people.

The main methods of training, which are used in the course, are lectures and discussion groups. Computer configurations with current illustrations are used to clarify the scientific material. Also practical demonstrations are used to train students on giving first aid and ways of saving people with technical recourses.

# **Contents of the course:**

The main types and characteristics of natural disasters. Extreme situations and their influence on the behavior of people. Posttraumatic stress disorders. Social and psychological aspects of terrorism. Main principles of action in earthquakes. Types of lifesaving actions, which are used on injured people in earthquakes. Defense methods in occurrence of floods from down pouring rains and tidal waves. Types of lifesaving actions and first aid in floods. Principles for action in occurrence of fires in residents and public buildings. The role of the social consultant.

# **Training and assessment technology:**

Lectures - the referred topics are studied in relevance of their specific nature and in all of them are used multimedia and computer configuration.

The main form of examination and grading of students is a written exam/test. Their knowledge and skills will be graded by the six-point system.

Testing procedures are: current control – it is implemented during the lectures and exercises; exam – the course is finished with a written exam, which includes test, theoretical questions, and practical tasks.
